


Figure 1: Percentage change between Q1 2010 and Q1 2011 for selected offence groups

Burglaries increase by almost 10% in Quarter 1

When comparing Quarter 1 2011 (Q1 2011) with Quarter 1 2010, recorded Group 07 *Burglary and related offences* increased by 8.5%. Increases were also observed in Group 08 *Theft and related offences* (+5.3%), Group 09 *Fraud, deception and related offences* (+4.2%) and Group 13 *Public order and other social code offences* (+1.4%).


Group 04 *Dangerous or negligent acts* decreased by 16.4%. Among other groups to show a decrease in Quarter 1 2011 were Group 10 *Controlled drug offences* (-12.3%) and Group 03 *Attempts or threats to murder, assaults, harassments and related offences* (-6.7%). See table 1.1 and figure 1.

When comparing the 12-month period ending in Q1 2011 with that ending in Q1 2010, an increase of almost 20% was observed in the number of recorded Group 06 *Robbery, extortion and hijacking offences*, with a similar percentage decrease observed in recorded Group 04 *Dangerous or negligent acts* (-19.4%). See table 1.2 and figure 4.

The rise in the number of recorded Sexual offences in 2010 was mainly due to an on-going review of all cases involving alleged Sexual offences reported to An Garda Síochána. Some of these offences will have occurred at some distance in the past but are represented on the date of reclassification. This review is being undertaken in conjunction with An Garda Síochána policy on the investigation of sexual crime, which was introduced in April 2010. Group 01 - Homicides

There were 13 recorded *Murder* offences in Q1 2011, a decrease of 3 on the same quarter in 2010. For the 12-month period ending in Q1 2011, there was a decrease (-13.1%) in the number of *Murder* and *Manslaughter* offences recorded, decreasing from 61 to 53, when compared with the same period ending in Q1 2010. The decrease in the number of *Dangerous driving leading to death* offences from 9 in Q1 2010 to 4 in Q1 2011 may be due to the fact that all road collision investigations for this period have not yet concluded, which will result in some being reclassified as *Homicide*. Group 02 - Sexual Offences

The number of offences in this group decreased by over 40% from 694 in Q1 2010 to 411 in Q1 2011. However, when considering the 12-month period ending in Q1 2011, there were 2,115 reported offences in this group, an increase of 22.0% on the 1,733 offences recorded for the corresponding period ending in Q1 2010. As noted above, caution should be used in interpreting these figures.

Group 03 - Attempts/Threats to Murder, Assaults, Harassments and Related Offences

The number of *Murder-threats* increased by 20.0% from 85 in Q1 2010 to 102 in Q1 2011. *Assault causing harm, poisoning* offences fell from 901 to 862 between Q1 2010 and the corresponding quarter in 2011. The largest number of offences in this group were recorded under *Other assault*, which fell from 11,568 in the 12-month period ending in March 2010 to 11,135 in the 12-months ending in March 2011.

Group 04 - Dangerous or Negligent Acts

In Q1 2011, recorded *Dangerous or negligent acts* offences decreased by over 15% to 2,570 when compared with Q1 2010. Most recorded offences in this group relate to *Driving/In charge of a vehicle while over legal alcohol limit* offences, which decreased from 2,636 (Q1 2010) to 2,360 (Q1 2011), a decrease of 10.5%. When considering the twelve-month total for the period ending in Q1 2011, there were 11,580 recorded Group 04 offences. This was a decrease of 19.4% on the corresponding period ending in Q1 2010.

Group 05 - Kidnapping and Related Offences

Comparing figures for Q1 2010 with Q1 2011, *False imprisonment* offences fell from 22 to 18, while there were 30 recorded *Human trafficking* offences for the 12-month period ending in March 2011, compared with 44 for the 12-month period ending in March 2010.

Group 06 - Robbery, Extortion and Hijacking Offences

The quarterly figure for *Robbery of an establishment or institution* fell by 8.0%, from 327 in Q1 2010 to 301 in Q1 2011. There were 1,932 recorded offences of *Robbery from the person* in the 12-month period ending in March 2011, a rise of over 30% on the corresponding period ending in March 2010.

Group 07 - Burglary and Related Offences

In Q1 2011, there were 6,443 recorded *Burglary (not aggravated)* offences representing an increase of 462 (+7.7%) on the number recorded in Q1 2010. *Aggravated burglary* offences increased by over 10% between Q1 2010 and Q1 2011, from 88 to 97. For the 12-month period ending in Q1 2011, recorded *Burglary (not aggravated)* offences decreased by 3.6% to 24,996 when compared with the corresponding period ending in Q1 2010. The annualised totals for *Burglary and related offences* are shown in figure 3.


Group 08 - Theft and Related Offences

Other thefts, handling stolen property offences increased by over 11% to 10,797 in Q1 2011. The annualised figure for *Theft from person* increased by 215 (+7.7%) to 2,997 in the 12-month period prior to the end of Q1 2011.

Group 09 - Fraud, Deception and Related Offences

There were 1,380 recorded *Fraud, deception and related offences* in Q1 2011. This was an increase of 55 (+4.2%) on the same period in Q1 2010. In the 12-month period ending in Q1 2011, *Fraud, deception and related offences* increased by 2.6% when compared with the corresponding period ending in Q1 2010, from 4,921 to 5,050.

Group 10 - Controlled Drug Offences

In Q1 2011, there were 4,170 recorded *Controlled drug offences*, a decrease of 12.3% on Q1 2010. There were 2,952 recorded offences of *Possession of drugs for personal use* offences in Q1 2011, a decrease of almost 15% on the corresponding figure in Q1 2010.

Group 11 - Weapons and Explosives Offences

There were 850 offences in Group 11 *Weapons and explosives offences*, in Q1 2011, a decrease of 3.3% on Q1 2010. *Possession of a firearm* offences fell from 104 in Q1 2010 to 76 in Q1 2011, a decrease of over 25%. The number of *Offensive weapons offences (nec)* rose from 2,912 for the twelve-month period ending in Q1 2010 to 3,034 for the same period ending in Q1 2011, an increase of over 4%.

Group 12 - Damage to Property and to the Environment

Recorded *Arson* offences have increased slightly (+5.3%) to 574 in Q1 2011. The largest number of offences recorded in this group was for *Criminal damage (not arson)*. These offences decreased by 1.3% to 8,891 in Q1 2011.

Group 13 - Public Order and other Social Code Offences

Recorded *Public order and other social code offences* rose by 1.4%, from 12,486 in Q1 2010 to 12,658 in Q1 2011. The most frequently occurring offences in this group were under *Disorderly conduct*, which rose from 10,703 in Q1 2010 to 10,937 in Q1 2011. This is equivalent to approximately 120 *Disorderly conduct* offences a day in Q1 2011.

Group 15 - Offences against Government, Justice Procedures and Organisation of Crime

There were 2,075 *Offences against Government, justice procedures and organisation of crime* recorded in Q1 2011, a decrease of almost 30% when compared with the same period in 2010.

Background Notes

Introduction The Crime Incidents, Quarter 1, 2011 release provides provisional figures for the number of offences recorded by An Garda Síochána, based on the Irish Crime Classification System (ICCS) but excluding elements of Group 4 (*Dangerous or Negligent Acts*), and all of Groups 14 (*Road and Traffic Offences (Not Elsewhere Classified or nec)*) and 16 (*Offences Not Elsewhere Classified*). Figures are provided from Quarter 1, 2008 to Quarter 1, 2011. The information supplied in this report refers only to crime incidents known to An Garda Síochána and recorded as such in the Garda PULSE (Police Using Leading Systems Effectively) system. Because of timing issues with respect to the extraction of data, figures may be revised subsequent to this publication.

Crime recording Incidents reported or which become known to members of An Garda Síochána are recorded when, on the balance of probability, a Garda determines that a criminal offence defined by law has taken place, and there is no credible evidence to the contrary. If it is subsequently determined that a criminal offence did not take place, the criminal offence recorded is invalidated and is not counted in the statistics. If a person makes a report and subsequently withdraws it by stating that the criminal act did not take place, then this too is invalidated unless there is evidence to suggest that, by reasonable probability, the offence has taken place.

For criminal offences where victim confirmation is required (e.g. assault, fraud), a criminal offence is recorded only where the victim confirms the offence or where there is evidence to suggest that by reasonable probability it occurred. Another important feature of a recorded offence is that it is based on the date reported to, or that it became known to, the Gardaí. This has major implications for some offence types. Notable amongst these are sexual offences, as it has often been the case that such incidents have been reported to An Garda Síochána many years (sometimes decades) after the event(s). Thus a sexual assault, which occurred in 1960, would be included in the statistics for 2008 if it was first reported in that year.

Crime classification A criminal offence is classified as a particular offence type at the initial recording of that offence. However, upon investigation, it may later become apparent that an alternative offence type should be used. In this event, the record is amended to reflect this. Re-classification on the basis of court proceedings only occurs in relation to homicide offences. A murder offence is reclassified as manslaughter when a charge of manslaughter commences or when a murder charge results in a conviction for manslaughter. It is also possible, though more rare, that an incident originally classified as manslaughter may be re-classified as murder. Also, a re-classification to a homicide offence occurs when, for example, a serious assault has been recorded and, some time later, the victim dies as a consequence of the assault.

General counting rules Crime counting rules are applied to all criminal offences for the purposes of the statistics. The following are the main rules relevant to the quarterly figures:

Primary Offence Rule: Where two or more criminal offences are disclosed in a single episode, it is the primary criminal offence that is counted. The primary offence is that offence which the greater penalty may apply. Where offences have similar penalties, offences against the person take precedence over offences against property for the purpose of determining the primary offence.

One Offence Counts Per Victim: One offence counts per victim involved with the exceptions of cheque/credit card fraud and burglary. Under certain circumstances, the cheque/credit card exception necessitates that a series of these offences counts as one crime where the originating bank ultimately suffers the loss. The burglary exception dictates that one burglary offence is counted where property belonging to two or more victims is stolen (or damaged) during a single burglary.

Continuous Series Involving the Same Victim and Same Offender: A continuous series of offences against the same victim involving the same offender counts as one offence.
