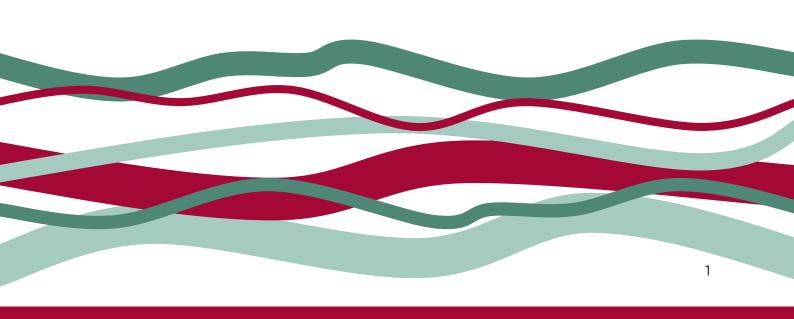


Health Service Executive July 2012 Performance Report National Service Plan 2012





Finance

The HSE is reporting a gross vote expenditure deficit of €270m at the 31st August, this is based upon the August Vote Report which is appended to this document.

On an accruals expenditure basis, the July figures contained in this performance report show a deficit of €350.9m. There is therefore no underlying reduction in the rate of expenditure across the business units of the HSE. Hospitals are running a deficit of €179.6m, Community Drug Schemes €121.9m and Community Services €66.3m.

At the end of July there were 33,000 additional medical cards over the <u>year end</u> target of 105,000 cards with a financial impact of €33m.

Given the level of budgetary reduction in 2012, aggressive cost containment plans have been in place since the beginning of the year. However as a result of the ongoing high demand for services these reductions have not been sufficient to deliver a balanced budget at year end.

An additional €130m of cost and cash measures are now required in order to deliver on a balanced vote at year end. The total value of the measures agreed with the DOH which will not impact on frontline services is €72.5m and implementation of these measures commenced on 1st September 2012. These include:

- €37 million through cash and stock management.
- Non service reductions of €29.5 million including savings in medical equipment, furniture, education and training, office expenses, computers, advertising, travel and subsistence, aids and appliances.
- €6m due to the delisting of various products from the PCRS reimbursable list. This reduction must been seen in the context of significant new drugs for illness such as Hepatitis C being introduced in 2012.

Human Resources

- The health sector is 1,778 WTEs below the current approved employment ceiling of **103,772** but more importantly 106 WTEs below the end of 2012 ceiling target of **102,100**.
- July employment shows a fall of 298 WTEs from June and compares with a decrease of 402 WTEs for the same month last year.
- The Statutory Sector, Voluntary Hospitals and Primary & Community Voluntary Sector recorded decreases of -195 WTEs, -12 WTEs and -92 WTEs respectively.
- The Integrated Services Directorate in overall terms recorded a decrease of -273 WTEs, with decreases in Acute Hospital Services of -106 WTEs and Primary and Community Services of -157 WTEs.
- The overall reduction is in the context of continuing upward growth pressures from contingency recruitment post 29th February as well as further enhanced controls on recruitment and cost containment. Planned new service developments in Mental Health and Primary Care have not yet taken place and no ceiling adjustment has been sanctioned.
- The HSE continues to pursue further efficiencies within the parameters of the Public Service Agreement.

Key Service Issues

- Inpatient discharges are 7.7% (25,130) above the NSP 2012 target and 2.3% (8,035 patients) higher than the same period last year.
- Day case rates are 5.6% (25,636) above the NSP 2012 target and 3.0% (14,050 patients) higher than the same period at end of July 2011.
- Emergency Admissions to Acute Hospitals are 6.7% (14,015) above NSP 2013 target and 2.4% (5,213 patients) higher than the same period last year. This is based on 48 out of 49 hospitals.
- At the end of July 5.6% of adults awaiting an elective procedure have been waiting longer than 9 months, a decrease of 85 people in the month. 26.6% of children have been waiting longer than the targeted 20 weeks, 237 less than in June. All hospitals continue to work towards the targeted date of 30th September.

Increased hospital activity may be accounted for by a reduction in the number of closed beds and the increase in the proportion of cases performed as day cases, up from 73% in 2011 to 76% in 2012. Nationally there were 833 inpatient and 19 day case beds reported closed for the week ending 29th July, 2012. The number of inpatient beds closed has decreased by 23.6% when compared to the same period last year (257 inpatient beds) as has the number of day bed closures which have decreased by 78.4% (69 beds).

One hospital, Midland Regional Hospital Tullamore did not submit activity data for July 2012.

The process for monitoring any potential breaches of the 28-day colonoscopy target continues. There has been a significant reduction in the level and frequency of breaches across hospitals. The HSE (in partnership with the NCSS) continue to meet to prepare for JAG accreditation process for endoscopes. The SDU GI Endoscopy Performance Improvement Programme has commenced. The Track and Trace and the Electronic Reporting System projects are progressing as per project plans.

Cancer Services

A very significant deterioration of performance for urgent referrals to Cork University Breast Cancer services was recorded in July. Only, 39.2% of urgent referrals were seen within the targeted timeframe of 10 working days. The hospital reports that this is due to capacity issues as well as less than optimal management of annual leave arrangements. 60% were seen within 14 working days with the remainder all seen within 17 working days.

Current Items for mention as of 7th September 2012

Comparison of year to date (2011 and 2012) ED cumulative trolleys

As of September 7th 2012, 22% fewer patients waited on trolleys since the beginning of the year compared to the same period in 2011. This equates to 13,450 fewer patients on trolleys.

Hayes Report

The HSE has published its final update on the implementation of the recommendations of the Hayes report on its website.

Senior Appointments

Human Resources:

Mr. Barry O'Brien has agreed to continue in the position as National Director of Human Resources for a further 12 months.

Hospital Performance Strategy:

By agreement with the Board of St. James Hospital, Mr Ian Carter, has been seconded to the HSE for a five year period and will be deployed to address performance issues in hospital settings.

Introduction of Online Payslips Service in the HSE

HSE staff and retirees in Dublin, Wicklow and Kildare and in Galway, Mayo and Roscommon will be able to use a new service to view and print their payslips online from September 2012 as part of a pilot project. This new service will allow payees easy access to their pay details 24 hours / 365 days. The new improved service will deliver cost savings for the health service and has potential to reduce payroll costs by in excess of €1m annually if fully implemented. It is the HSE's intention to expand this service to all parts of the country for staff and retirees. The roll out of this service will be on a phased basis in late 2012 / early 2013.

Value for Money Policy & Review

The Value for Money Policy and Review was published in July 2012. This report outlines the type of efficiencies that can be achieved across the range of disability services funded by the HSE.

National Hepatitis C Strategy

The HSE launched its **National Hepatitis C Strategy**, which provides a framework for a coordinated and integrated response to Hepatitis C in Ireland. It is estimated that between 20,000 and 50,000 people in Ireland are infected with the Hepatitis C virus.

No hospital reached the target of 95% of all attendees at ED being discharged or admitted within 6 hours, or 100% of people admitted within 9 hours of registration in July. The **top performing hospitals**, those who reached a performance level of 80% or above for all attendees being seen within 6 hours are Tullamore, St Luke's Kilkenny, Letterkenny, Portiuncula and St John's. Hospitals who reached 90% or above in relation to those who were admitted within 9 hours were St Luke's Kilkenny, Letterkenny, Portiuncula and St John's Hospital in Limerick.

The **hospitals which faced the greatest challenge** in reaching the 6 hour target for all attendees (reporting a performance at 50% or under) was the Mater (49.8%). The **hospitals which faced the greatest challenge** in reaching the 9 hour target for people admitted (reporting a performance at 30% or under) were the Mater (14.3%) and Beaumont (20.1%).

As reported by the hospitals to the Special Delivery Unit via TrolleyGAR, nationally across 28 hospitals the average number of ED patients waiting on trolleys during August 2012 is as follows:

- At 8am an average of 170 patients were waiting per day, of this number 68 patients waited greater than 9 hours, same period last year shows an average of 270 patients waiting at 8am.
- At 2pm an average of 104 patients were waiting, of these 52 patients were waiting greater then 9 hours, same period last year shows an average of 170 patients waiting at 2pm.
- At 8pm an average of 99 patients were waiting, of these 26 were waiting greater then 9 hours.

Elective Waiting Time

Percentage of Adults waiting greater than 9 months for an elective procedure (M)

It is intended that no adults will be waiting greater than 9 months for an elective procedure by 30 September 2012. Hospitals are actively working to reach the September target.

At the end of July, there were 2,865 (Inpatients 927 + Day Case 1,938) adults waiting greater than 9 months for an elective procedure. This represents 5.6% of the adult waiting list for elective procedures and shows a decrease of 85 patients compared to the position at the end of June.

Percentage of Children waiting greater than 20 weeks for an elective procedure (M)

It is intended that no children will be waiting greater than 20 weeks for an elective procedure by 30 September 2012. Hospitals are actively working to reach the September target. At the end of July, 1,014 (Inpatients 439 + Day Case 575) children were waiting greater than 20 weeks for an elective procedure. This represents 26.6% of the child waiting list for elective procedures and shows a decrease of 237 patients compared to the position at the end of June.

Colonoscopy / Gastrointestinal Service

No. of people waiting more than 4 weeks for an urgent colonoscopy (M)

Census week ending 29th July reports 4 patients waiting >28 days, from referral, for an urgent (priority 1) colonoscopy. The numbers waiting refer to two hospitals, 1 in Midland Regional Hospital Tullamore and 3 in Cork University Hospital. These patients have how had their procedure.

Number of patients waiting greater than 3 months following a referral for a Gastrointestinal Endoscopy (M

It is intended that no patient will be waiting greater than 3 months following a referral for a GI Endoscopy by 30 September 2012. Hospitals are actively working to reach the September target. At the end of July, there were 3,052 patients waiting greater than 3 months for a GI Endoscopy. This represents 28.2% of all patients currently waiting and shows a decrease of 1,270 patients compared to the position at the end of June.



Other Acute performance indicators and activity data

Time to surgery: % of emergency hip fracture surgery carried out within 48 hours (pre-op LOS: 0, 1 or 2) (M)

82% of emergency hip fracture surgery was carried out within 48 hours (pre-op LOS: 0, 1 or 2 days) in July against a target of 95%.

This is reported through HIPE and is based on a rolling 12 month period from August 2011 to July 2012.

Admission on day of procedure: % elective inpatients who had principle procedure conducted on day of admission(M)

52% of patients had their principle procedure on the same day as they were admitted against a target of 75%. This compares to 49% for the equivalent reporting period in 2011.

This is reported through HIPE and is based on a rolling 12 month period from August 2011 to July 2012.

% day case surgeries as a % of day case + inpatient for specified basket of procedures (General Surgery, ENT, Ophthalmology) (M)

76% of the chosen basket of procedures were carried out on a day care basis against a target of 75%. This compares to 73% for the equivalent reporting period in 2011.

This is reported through HIPE and is based on a rolling 12 month period from August 2011 to July 2012.

Medical patient average length of stay (ALOS) (M)

The National figure for medical inpatient average length of stay (ALOS) from Jan-Jul 2012 is 7.4 days. This shows an improved performance when compared to 8.9 days in 2010. The target set for the programme post full implementation for ALOS is 5.8 days. The Acute Medicine Programme reviews hospitals according to where they are in the 3 year improvement programme. The timely placement of medical inpatients from Hospitals and the availability of services such as Home Care Packages effects performance in this area.

This is reported through HIPE and is based on July 2012 data.

Re-admission: % of emergency re-admissions for acute medical conditions to the same hospital within 28 days of discharge (M)

There was a re-admission rate of 11% for acute medical conditions, to the same hospital within 28 days of discharge. The target for 2012 is 9.6%.

This is reported through HIPE and is based on a rolling 12 month period from August 2011 to July 2012.

Inpatient Discharges (M)

49, 331 inpatient discharges were reported in July 2012 (based on 48 of 49 returns). Year to date to end of July 352,431 inpatients have been discharged.

Analysis shows that inpatient discharges are 7.7% above target and 2.3% above last years levels at the end of July. However, a true reflection comparing actual activity versus target activity for those hospitals who returned data in June, inpatient discharges are 7.9% higher than target year to date and 2.6% higher than the same period for 2011.

Day Case Discharges(M)

69,730 day cases were reported as discharged in July 2012 (based on 49/50 returns). Year to date to end of July 485,757 day cases have been reported as discharged.

Analysis shows that day cases are 5.6% above target and 3% above last years levels at the end of July. However, a true reflection comparing actual activity versus target activity for those hospitals who returned data in June, day cases are 5.8% higher than target year to date and 3.2% higher than the same period last year.

Delayed discharges: Number of Delayed Discharges and Reduction in bed days lost through delayed discharges (M)

At the end of July there were 664 people who had completed their acute phase of care and were medically fit for discharge. This is a decrease on the number of 703 reported at the end of June.

An estimated 23,160 bed days were used in July by patients who had completed their acute phase of care and were medically fit for discharge.

Bed Closures

Nationally there were 852 beds reported closed for the week ending 29th July 2012, an overall increase on the position in June but July saw the opening of day care beds reflecting activity in this area.

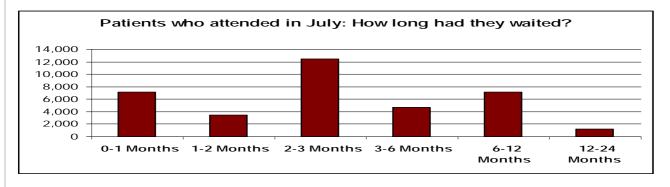

A first responder is a person, trained as a minimum in basic life support and the use of a defibrillator, who attends a potentially life-threatening emergency. This response may be by the National Ambulance Service (NAS) or by a community /co-responder based First Responder Scheme which is integrated with the National Ambulance Service.

The availability, integration and measurement of First Responders is at an embryonic stage in Ireland. NAS does not have access to sufficient numbers of First Responders or access to the technology required to capture the necessary data. In this context, the performance reported is conservative and may not represent all of the patients whom benefit from the arrival of a Community based First Responder. NAS will be working with voluntary groups over the coming years to expand the availability of First Responders and plans to invest in improved technology in 2013.

The NAS developed an action plan which has resulted in improved trajectory in response time performance in 10 of 12 months during 2011. However, as no additional resources are available in 2012, our ability to address the newly agreed national targets will be challenging. The use of emergency ambulances for inter facility transfers continues to be one of the most significant impediments to achieving improvements in transporting vehicle response times.

It is carried out by healthcare professionals e.g. geriatrician, nurse and considers whether the applicant can be supported to continue living at home or whether long-term nursing home care is more appropriate. Applicants must be assessed as needing long-term residential care services to be eligible for State Support or the Nursing Home Loan.

The issue relates to the methodology used to count hours. Within HSE South, Cork and Kerry operate on a 4 week pay period which gives them a 13th month. In previous years they gave profiled home help hours targets which took account of this and meant the December target was always higher then the other months. This year they have just done a crude divide by 12 for the monthly target. The result has been that their variance to target has been skewed and showing them further away from target then they are. So they have included the additional pay period in the July return and this has normalised their figures and brought them back on target. It means that when you look at the month of June and July for Cork and Kerry the July figures are nearly double the June ones.

The Schemes, including local expenditure, have incurred expenditure of €1.557m versus their budget of €1.435m resulting in a deficit of €121m year to date. The National Service Plan 2012 set out the policies, supported by legislative changes, to provide scope for driving further reductions in drug pricing. These initiatives were designed to generate full year savings totalling at least €100m this year. Their delivery is dependent upon agreement with the Irish Pharmaceutical Healthcare Association (IPHA) among others together with the enactment of the requisite legislation by Government.

PCRS is forecasting a full year deficit of approximately €146m for medical card and national primary care schemes and €59m for local schemes bringing the overall projected deficit for the Schemes to €205m for 2012. Achievement of a breakeven position by year end is at serious risk for the following reasons;

• Increased demand for services – The number of persons eligible for a medical card has risen from 1,694,063 (as at 1 January 2012) to 1,832,865 (as at 1 August 2012) i.e. growth of +138,802 persons eligible for medical cards year to date. The main part of this increase relates to the clearing up of a backlog of applications from last year which was completed at the end of April 2012 and additional new eligibilities in the first five months of this year. However the rate of growth, month on month, since the 1 May 2012 has been declining as demonstrated by Table 1. The number of items reimbursed on the GMS scheme has grown by +2.439m items based upon a year on year comparison.

- Absence of agreement to implement specific savings initiatives totalling €100m As stated, a number of policy initiatives agreed with the Department of Health, are included in the National Service Plan 2012. These savings will not be delivered as negotiations with the IPHA among others have failed to achieve the requisite quantum of savings. This presents serious funding implications for the HSE this year.
- Agreement to reimburse 'new' drugs National Service Plan 2012 did not provide additional funding for the
 introduction of new drugs during the year. The decision to introduce new drugs creates an additional cost pressure for
 Schemes which will have to be considered in the context of total Schemes expenditure this year.
- Local schemes budgetary control The national Schemes budget provides €156m for expenditure in relation to loca schemes e.g. Hardship, etc. Local budgetary management is required as a matter of priority to bring expenditure back into line with budget this year. Demand led expenditure incurred by the local areas is accounting for €59m of the Schemes forecast deficit for 2012.

As at the 20 August 2012, 96.6% of properly completed medical card applications have been processed within the 15 day turnaround. The remaining 3.4% are being processed. 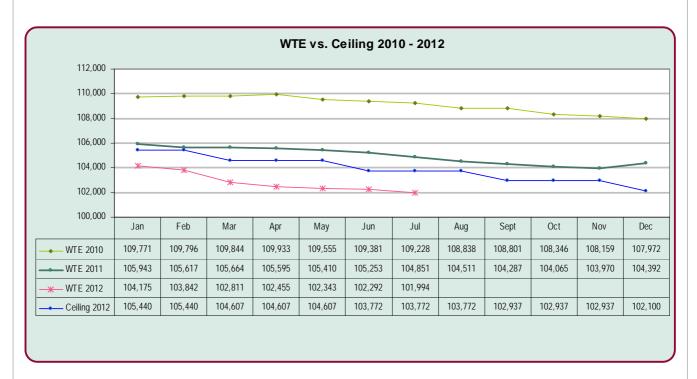

Human Resources



The health sector is 1,778 WTEs below the current approved employment ceiling of 103,772. July employment shows a fall of 298 WTEs from June and compares with a decrease of 402 WTEs for the same month last year. This reduction is in the context of continuing upward growth pressures from contingency recruitment post 29th February and ongoing filling of new service developments as well as further enhanced controls on recruitment and cost containment.

The Integrated Services Directorate in overall terms recorded a decrease of -273 WTEs, with decreases in Acute Hospital Services of -106 WTEs and Primary and Community Services of -157 WTEs.

Human Resources

- Medical/Dental staffing recorded a monthly decrease of 66 WTEs (-154 WTEs in YTD).
- Nursing is showing a decrease of -76 WTEs, (-998 since end 2011). The reduction seen since the end of 2011 is still less than anticipated arising from 'grace period' retirements and may have been somewhat offset by contingency recruitment post 29th February and the continuing failure to fully displace student nurse placements from the start of the year.
- Health & Social Care Professionals showed the largest decrease, by 81 WTEs (-382 WTEs since end 2011).
 Management/admin decreased by 74 WTEs (-255 WTEs since end 2011). It should be noted that this staff category has reduced by 2,694 WTEs (-14.62%) since its peak in September 2007 and are now at levels last seen in December 2003, despite significant subsumed admin staff and the creation of other new posts in this category in the intervening period.
- General Support Staff increased by 16 WTEs, primarily accounted for through increases in household and other support staff in HSE South (-293 WTEs since end 2011).
- Other Patient & Client Care decreased by 17 WTEs since June (-316 since end 2011).

- In relation to "exempted grades"; Consultant WTEs increased by 15 WTEs and are showing a 5 WTE increase, year-to-date primarily due to the impact of grace period retirements. They are 211 WTEs above the March 2009 levels. Increases in Consultant WTEs seen in recent years have resulted in them now constituting some 2.43% of overall health sector employment, up from 2.01% in 2008. NCHDs WTEs decreased by 62 WTEs (-112 WTEs in YTD) in July and are 24 WTEs ahead of 2009 levels.
- Physiotherapists, Speech and Language Therapists and Occupational Therapists all recorded decreases of -10 WTEs, -7 WTEs and -9 WTEs respectively.
- Social Worker grades recorded a decrease of -5 WTEs, but are still some 188 WTEs above the 2009 levels. No
 additional posts under Children and Families 2010 (Ryan Report) and the National Service Plan 2011 were filled in July.
 The recruitment process to fill the 64 outstanding posts approved in the National Service Plan 2010 is still ongoing, as are
 the remaining 2.25 WTE development posts set out in the National Service Plan 2011. Psychologists and Counsellors
 decreased by -2 WTEs this month.

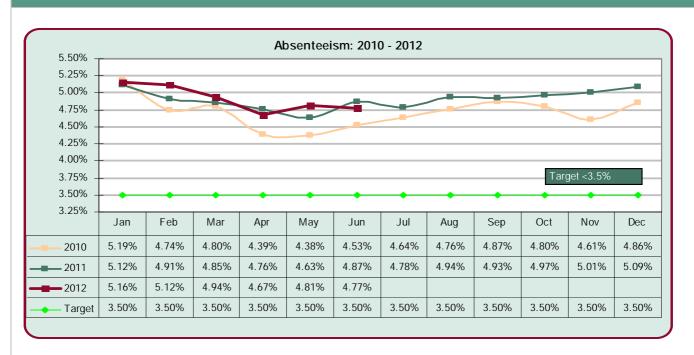

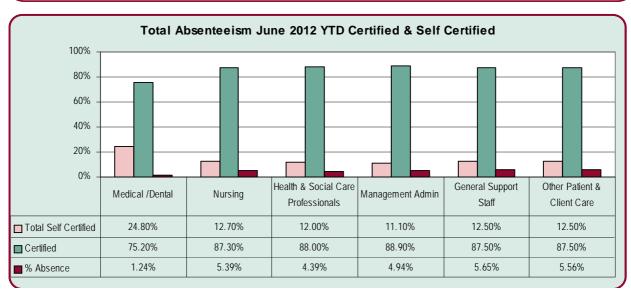

2. Comparison to Issues Return

The August return is €10m greater than the issues return submitted on 27th August 2012. This is due to increased cash requirements in the last week of August.

3. General Commentary

Arising from the recent difficulties experienced with Ulster Bank the August vote expenditure figures cannot be confirmed until all bank balances are fully updated and reconciled.

The August vote expenditure return is prepared on the basis of cash issued to HSE areas and includes estimates of appropriations-in-aid collected directly by the HSE. Other receipts are actual receipts from the Revenue Commissioners and receipts from the UK Department of Health in relation to the recovery of EU health costs.

The outturn for Subhead B.12 – Long Term Residential Care is returned at the REV profile at 31st August 2012. Recent clarification from D/PER in relation to the appropriate charge to be applied to this subhead has been received. The charge to the subhead will be reviewed on this basis.

The outturn for Subhead B.15 - Children & Family Services is returned at the REV profile at 31st August 2012 as the actual outturn is not available.

Therefore while the gross expenditure is correct the individual subhead totals in the attached return are subject to amendment.

Gross current vote expenditure is €270m over profile, while current appropriations-in-aid collected directly by the HSE are €59m under profile resulting in a **net current overspend of €329m** (€254m at the end of July, 2012).

EU appropriations in aid are €130m ahead of profile as €130m was received from the UK Department of Health in July 2012. This receipt was not profiled for collection until September and December 2012. Other current appropriations-in-aid are on profile.

Gross capital expenditure is €20m under profile and capital appropriations in aid are €1m under profile.

4. Emerging Issues by Vote Subhead based on REV Allocation

- The statutory sector is €56m over profile (€44m over profile in July).
- The voluntary sector is €98m over profile (€88m over profile in July).
- The medical card services and community schemes, on a gross basis, is €147m over profile and on a net basis is €142m over profile (€117m over profile on a net basis in July).
- Pension Lump Sum Payments are €16m under profile (€12m under profile in July).
- Payments to the State Claims Agency are €15m under profile (€19m under profile in July).

5. Year End Revenue Projection

Based on the existing cash spend rate the projected year end revenue deficit is €500m. In light of the actions agreed and subject to their full implementation, the vote outturn will be significantly improved and would result in at €60m vote deficit. The return which accompanies this report has been prepared on the basis of a balanced vote at year end.

C3 ICT

Gross current vote expenditure is €221m over profile, while current appropriations-in-aid collected directly by the HSE are €33m under profile resulting in a **net current overspend of €254m** (€207m at the end of June, 2012).

EU appropriations in aid are €130m ahead of profile as €130m was received from the UK Department of Health in July 2012. This receipt was not profiled for collection until September and December 2012. Other current appropriations-in-aid are on profile.

Gross capital expenditure is $\[mathcal{e}\]$ 27m under profile and capital appropriations in aid are $\[mathcal{e}\]$ 22m under profile.
