Highlights of the Year

WRDTF Drug and Alcohol Awareness Week

The Drug and Alcohol Awareness week was the first regional week to take place after the very successful Mayo Awareness event in 2011. It was held in Galway, Mayo and Roscommon from the 12th to the 18th November. There was a packed programme of activities and information events rolled out across many towns in the region. It was the first region-wide focus that put drugs and particularly alcohol under the spotlight.

It was launched in Breaffy House, Castlebar, by Dara Calleary, Fianna Fáil TD for Mayo. Its purpose was to increase public awareness around drug and alcohol related issues in the region and highlight drug & alcohol support services to people in Mayo, Galway and Roscommon. It had a special focus on the many needs of families faced with drug or alcohol difficulties. Its aim was also to highlight alcohol as the most widely misused drug in the region.

Of the fifty-two events that took place, twenty-seven of those were from community and voluntary groups who were awarded small grants from the WRDTF. These ranged from coffee mornings to parent information evenings to flash mobs, art and sport. The first issue of our Newsletter *TF News* is devoted to the events of the week.

52 events took place throughout counties Mayo, Roscommon and Galway



ICE Campaign

Following on from the success of the ICE Campaign in 2011, it was rolled out again this year with a radio campaign beginning on November 1st.

This campaign 'In Case of Emergency' is to encourage people to store their next of kin's contact details in their mobile phone. An advertisement campaign in relation to it was run in the main papers of the three counties and also on Galway Bay FM.

A Facebook page was developed as part of the social media campaign. The information was also forwarded to An Garda Síochána for distribution and placed on their website, public notice boards, staff rooms and within the emergency services.



CRAFT

Community Reinforcement and Family Training (CRAFT) was held in the Clayton Hotel on 27th and 28th of February. It was presented by Robert J. Meyers, PhD, from the University of Mexico, who created and developed the training. The CRAFT programme works to change a patient's environment in order to make a non-substance using lifestyle more rewarding than one focussed on the use of alcohol or other drugs. In the CRAFT model, concerned significant others (CSOs) are the focus of the therapy instead of the substance abuser. CSOs receive training to change their interactions with the substance-using person, reducing their enabling behaviours and improving their communication strategies.

The two-day training course was open to all front line workers in the region and was available only to those who worked directly with family members of people with addictions. It covered many aspects of community reinforcement and family training, including the scientific support for CRAFT and new uses.

It initially consisted of on-site training with Dr Meyers. The applicant had to be in a position to participate in a peer-led support group monthly to discuss how he/she was proceeding with the process of accreditation.

To become accredited the individual also had to be in a position to audio tape sessions with family members as part of the accreditation process. The finished tapes were sent to the US for assessment.

Already a number of participants have been accredited.

Drug Driving Campaign

The Western Region Drugs Task Force in conjunction with the Road Safety authority (RSA) and An Garda Síochána, launched a campaign to highlight that driving under the influence of drugs is just as dangerous as driving under the influence of alcohol. 'It's also against the law,' said Noel Brett, Chief Executive of the RSA when it was launched in Ballina, Co. Mayo on November 19th



The clear message to drug drivers was, "Say goodbye to your licence and hello to An Garda Síochána". This banishes any notion that drug drivers are either competent or undetectable.

Radio interviews, over five radio stations in the three counties, highlighted the campaign and raised awareness.

Garda Commissioner for the West, Donal Ó Cualáin, said that driving under the influence of drink or drugs not only put the driver at risk but also innocent passengers and other road users.

Drug and Alcohol Small Grants and Family Support Grants

There were two rounds of the grants in May and November.

In May, the Admin/Finance sub-group reviewed a total of 41 applicants in relation to Small Grants. Of those, 16 were successful, which was a total of €13,035 granted.

Eleven organisations applied for the Family Support Grants. There were 7 successful applicants with a total of €11,900 granted.

In November, the Admin/Finance group reviewed and signed off on Round 2, 2012 Drug & Alcohol Small Grants and Family Support Grants.

There were 11 applications for the Family Support Grant and ten of those were successful. A total of €10,000 was paid out on this grant.

17 organisations applied for funding for the Small Grants. There were 11 successful applicants. A total of €10,000 was paid out on this grant.

Overview of 2012

Prevention

The Fancy Backpacking and Crime Stopper posters were distributed to schools and youth clubs in the three counties.

The launch of the Festival Care Booklet took place on 26th June in the Galway City Museum. It was launched by Mayor Terry O'Flaherty. As former representative on the Task Force Committee she was delighted to do the honours.(See highlights)

The National Putting the Pieces Together Training was held in Athlone

The Task Force supported attendance at the ADHD Conference which took place on the 5th October in the Sheraton Hotel Athlone. INCADDS ran a seminar titled 'Psychological thinking and treatment into making an invisible disability transparent' 'Fireworks in the Brain'.

The Drug and Alcohol Awareness Week took place from 12th-18th November with a packed programme of events throughout Galway Mayo and Roscommon. The launch was held in Breaffy House, Castlebar and guest speaker was Dara Calleary, Fianna Fáil TD for Mayo. (See highlights)

On 19th November the WRDTF in conjunction with the Road Safety Authority and An Garda Síochána launched a campaign, in Ballina, Co. Numerous prevention education initiatives took place throughout the year including the continued roll out of the Parent Drug Education Multi-Agency Initiative.

Treatment & Rehab

Stephen Coyne, HSE Community Substance Misuse Counsellor presented information on diagnostic tools to identify ADHD and substance use at the WRDTF Meeting on the 22nd February

Community Reinforcement and Family Training (CRAFT) was held in the Clayton Hotel on February 27th and 28th. It was presented by Robert J. Meyers, PhD. (See highlights)

Brendan Murphy gave a presentation on the INDRIC model to WRDTF.

From the group trained in February in the Clayton, Olive Bane HSE West Drug Counsellor became the first person in the west of Ireland accredited with CRAFT Training.

Family Support grants were advertised and awarded to groups in the region.

Admin/Finance

The Admin/Finance group reviewed both rounds of the Small Grants and Family Support Grants (See highlights for details.)

The Task Force AGM took place on the 5th July. The admin/group reviewed and signed off on the WRDTF Accounts for 2011. Pauline Busby resigned as Company secretary and was replaced by Edith Geraghty.

After months of negotiation the Chairperson and the office administrator successfully negotiated a reduced lease for the Task Force Offices.

The Admin group reviewed the 2012 Small Grants & Family Support Grants Application forms. A number of changes were made to the forms including making them colour coded.

Admin/Finance Sub-group meetings took place in 2012.

Research/Evaluation

The Research Evaluation Sub-group worked on the proposal for research on Substance Use and ADHD, a joint project with INCADDS (Irish National Council for AD/HD Support Groups). A researcher was selected and the research will be carried out between January and September 2013.

Project Steering Committees for each of the funded posts took place on a quarterly basis throughout the year.

A tender document was developed and advertised for the Evaluation of Parents Drug Education Multi-agency Initiative. After a selection process, a researcher was chosen to complete this evaluation. The evaluation will be completed between January and April 2013 and will be overseen by the Research/ Evaluation sub-group.

Research/Evaluation sub-group meetings took place in 2012.

WRDTF Committee and Team

The DPU carried out a review of all RDTFs which was to be completed by April 1st. The Task Force staff circulated a questionnaire to all Task Force representatives and asked them to answer the following three questions.

- 1. Drug use in your area.
- 2. Emerging trends in drug use.
- 3. Identify the main service gaps and major blockages to delivering a more effective drug service and successful outcome for problem drug users in your area.

This information was compiled and a report was sent to the DPU.

Conference call facilities came online in the meeting room at the Task Force offices and were used for a number of meetings.

The Service Level Agreements (SLAs) were sent to all host organisations for completion.

A staff information day took place on the 29th August in the Clayton. At the meeting everyone was thanked for their work throughout the year. Discussions took place around the upcoming 2012 Drug & Alcohol Awareness week, and the publication of a newsletter.

The WRDTF website was updated to incorporate the ICE Campaign. The campaign was rolled out on radio and posters from November 1st 2012 to January 31st 2013.

Bi-annual funding was released to the host agencies in January and July.

The First Task Force newsletter was launched on the 13th December.

On December 10th 2012 the Task Force received a 3% funding cut. The committee met on December 13th to review the cuts. A number of options were made available to the Task Force. The group agreed to cut the funding for the NUIG substance Misuse Counsellor.

In line with the DPU request, work on the operational guidelines began. A Task Force facilitation day to review the draft Guidelines was held in the Clayton Hotel on Tuesday 20th November 2012. The Guidelines were ratified by the Task Force on December 13th.

A WRDTF training calendar was developed and includes all trainings available from the Education Support Workers funded by the Task Force. The calendar will also include training delivered by some external agencies in conjunction with the WRDTF e.g. National Family Support Network. The calendar will be circulated widely in early 2013.

Working in partnership with the Galway Healthy Cities Alcohol Forum, members of TF staff have been engaged in the development of a 5-year strategy for Galway City. Wide consultation has taken place and the group receives support from alcohol specialist, Dr Ann Hope. This document fits well with the national and regional strategies and will be launched by Minister Alex White in early 2013.



Festival Care Guide: Guidelines on the management of alcohol and its related harms at festivals and events

In conjunction with Galway City Council, a Festival Care Guide was launched on 26th June in the Galway City Museum by Mayor Terry O'Flaherty prior to the Volvo Ocean Race. Based on the North West Alcohol Forum document, it is to be used as a support rather than a comprehensive festival plan. It aims to assist festival organisers or promoters to address the possible negative consequences that arise from alcohol misuse by offering guidance on the management of alcohol and its related harms at events. It also provides a communication plan for events that focuses on issues such as personal safety and information for parents. It includes information on Open Space Permits, licences for outdoor events, what to do in an emergency and checklist for festival organisers. The Task Force is in the process of rolling this out throughout the region.

Operational Guidelines

Another large project which was completed this year was the Operational Guidelines document. In line with the directive from the DPU and referring to: the Local and Regional Drugs Task Forces Handbook, February 2011, the Template from the National Drugs Strategy Team (January 2005) and the minutes of the WRDTF Committee meetings, a draft document was drawn up.

The document contains objectives; terms of reference and composition of the Task Force; Task Force meetings; sub-groups; monitoring and evaluation of TF projects; funding and finances.

Before it was sent to the DPU, a facilitation day to ratify outstanding items of the draft was held in the Clayton Hotel on Tuesday 20th November 2012 at 10.00am.

The final document was ratified at the Task Force meeting on 13^{th} December and forwarded to the DPU.

TF News

It was decided that the Task Force would produce a newsletter that would inform the main funders, board, staff, funded workers and communities of activities within the WRDTF. Its aim is to keep representatives up-to-date on all funded projects, publications and services in the region. It will be published a number of times a year to highlight the initiatives/projects engaged in, or developed by the management, funded workers and staff of the WRDTF.

The first issue focused on the very successful Drug and Alcohol Awareness week, 2012. A total of fifty-two events were held in counties Galway, Mayo & Roscommon between the 12th and 18th of November. All events were mentioned in the issue and those that were highlighted included 'Success in Sport'; 'Teenage years'; 'Empowering the Community'; 'Sozzled' and Alcohol and Pregnancy Don't Mix.
