* To ask the Minister for Health if he will provide in tabular form the number of persons who sought drug treatment and rehabilitation services broken down by county or local health area for each of the past five years and to date in 2014; and if he will make a statement on the matter.

PQ 32557/14

* To ask the Minister for Health the number of people who accessed drug treatment and rehabilitation services broken down by county or local health area for each of the past five years and to date in 2014; and if he will make a statement on the matter.

Dear Deputy Kelleher,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Questions, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

Between 2008 and 2012 there were 44,345 cases assessed for drug treatment recorded in the National Drug Treatment Reporting System (NDTRS) (Table 1). Table 2 sets out cases assessed by county of residence between 2008 and 2012. Data for 2013 and 2014 is not yet available. For the purpose of the NDTRS, treatment is broadly defined as 'any activity which aims to ameliorate the psychological, medical or social state of individuals who seek help for their substance misuse problems'. Clients who attend needle-exchange services are not included in this reporting system.

There are many reasons why a case, once assessed, does not go on to receive treatment. For example (in no particular order): unsuitable for drug treatment, placed on a waiting list, transferred to another drug treatment site, did not fulfil admission criteria or did not wish to take up the place.

Between 2008 and 2012 36,083 cases entered drug treatment as recorded in the NDTRS (Table 3). Data for 2013 and 2014 is not yet available. Table 4 sets out cases receiving drug treatment by county of residence between 2008 and 2012. Data for 2013 and 2014 is not yet available. Tables 5 – 9 identify the treatment status of these cases and classify them as: "New Cases", "Previously Treated Cases", or "Status Unknown"

New cases treated – describes individuals who have never been treated for problem drug use;

Previously treated cases – describes individuals who were treated previously for problem drug use at any treatment centre and have returned to treatment in the reporting year; and

Status unknown – describes individuals whose status with respect to previous treatment for problem drug use is not known.

Note, in the case of the data for 'previously treated cases', there is a possibility that individuals appear more than once in the database: for example, where a person receives treatment at more than one centre or at the same centre more than once per year.
