## **Chairperson's Statement**



#### A year like no other

2020 was a most unusual and difficult year for everyone around the world, not least for us here in

Turas. However, we remained committed to our mission to ensure people in addiction were met with a confidential and nonjudgemental space and when we couldn't meet in person we quickly moved our services online.

When Covid arrived we quickly altered our services to provide them remotely and worked tirelessly during the year to tweak and temper them to develop the best practice model we now have.

We offered 2,288 sessions to 272 people using face-to-face, online and telephone methods to ensure people in Dundalk and surrounds replaced an addiction filled lockdown with one of solace, contemplation and hope.

In March 2020 we had no idea for long these new changes would continue but we kept going, developed new services and alternative approaches to service delivery while remaining steadfast in our commitment to people with addiction. We offered all of our normal services and even added to them to meet unmet needs we were presented with. In addition we worked with asylum seekers in isolation to provide a listening ear and psychosocial interventions. We also collaborated with FoodCloud to receive and distribute food to our clients financially challenged by the pandemic.

Throughout it all we were driven by our ethos of respect, acceptance and non-judgement and remained dedicated to our clients who have told us the immeasurable difference Turas made in their lives.

I would like to thank the HSE and the North East Regional Drug and Alcohol Task Force for their financial support towards funding the service and in particular the Court Services for their donations throughout the year.

I would like to thank all of our staff and management for their dedication and commitment to finding solutions to the difficulties Covid-19 presented, in a way that enabled us to continue to provide a first class service and for remaining constant throughout with our clients as their priority. I would also like to thank all of our board members for their work and support throughout the year.

A society where people overcoming addiction can live fulfilling, healthy and substance free lives.


#### **Mission**

**Compassion** – we provide a welcoming, compassionate and trusting environment




**Dignity** – we respect and support people to develop their own potential

## **Mary's Story**



Mary spent most of her life caring for her husband who had depression, her children and her ageing parents. After her children moved out, her husband also left and her parents both died around the same time. Suddenly she felt alone.

She began working in a job that she later realised was putting her down, demeaning and critical of her every move.


Terrified of the future and tired of life, alcohol slowly became the only thing that mattered to Mary because it helped her to feel numb of all the pain she had endured throughout her life. One morning her daughter arrived at her door sobbing to see the way her mother had become and Mary herself knew it was time to be honest with herself and admit that she needed help.

Talking to her GP, he recommended Turas, and she made her way straight down to us. Shaking with fear she was met with kindness, acceptance and understanding. "I want me to happen to life, instead of life happening to me" she said on arrival. Immediately she felt understood and knew she was in the right place.

Through attending group work and oneto-one sessions she delved into who she really was for the first time and blossomed. She finally learned what a Sunday felt like because she was no longer hungover. Mary lives now with her senses open, her mind at ease and feels fully alive.

She knows that she is brilliant and has hope for the future.

## Year in review

We began in January with hope and excitement for a new year. By March we heard about lockdown's in China and within a few short weeks we were thrown into a very challenging, disorienting and unknown world. But we coped, and indeed thrived in our commitment to ensuring that addiction was not going to be another problem added to peoples already tumultuous lives.

Turas responded with strength, decisiveness and flexibility and made the new way work. We supported more clients than in 2019 and we also provided far more sessions because people were at home with less distractions and some fantastic work was done with our clients.

We kept communication with all of the team, the board and our clients open from the outset which helped with a smooth transition to our 'new normal'. Turas knew that to succeed in such an unpredictable and fluid space it required us to be flexible in our approach and offer new services and programmes when required.

On the request of the North East Regional Drug and Alcohol Task Force we provided daily support to asylum seekers in isolation staying at the Carnbeg Hotel. We continued this for a number of weeks until the service was no longer required.

We also offered weekly meditation classes to ensure all of our clients had access to a mindful and calm space to help them deal with their addiction during such a restricted time. Turas further broadened our services to meet need and collaborated with FoodCloud to provide food to our clients in financial difficulty. We would collect food from Tesco and contact clients whom we would meet at Turas, or for those immobile, we would deliver it to their door.

On the operations front we made several interventions to establish a system that worked for our staff and clients and these were supported by buying staff mobile phones, which were funded by Dundalk Credit Union. These have become a vital part of our ability to provide our service.

Thanks to funding from the HSE/NERDATF and Louth County Council we were able to ensure all staff also had a laptop and to conduct a full Covid risk assessment and deep clean before we returned to working face-to-face.

We developed a Covid policy and a remote working policy and required all staff to undertake a home health and safety risk assessment of their home work space. We held team meetings every Wednesday morning to discuss client issues, self-care and any struggles with working from home.

While we managed to do fantastic work during Covid it is important to note that core issues facing some of our clients such as dual diagnosis and the lack of detox support, particularly in relation to benzodiazepines, continue to be a problem and we have continued worked together with the NERDATF to find long-term solutions. Our strategic plan launch in September by Minister with Responsibility for Drugs Frank Feighan laid the foundations for advocacy to continue on these issues and to develop our fundraising, purchase a new building, improve staff wellbeing, develop a dropin service and CE scheme. While Covid has slowed some of these down it has not deterred us in achieving our aims and we will continue to work on these into 2021 and 2022. We have worked hard to ensure we are compliant with the Charities Governance Code in 2020 and will continue to comply with this going forward.

# **Communications Support**

Turas responded to a call from the Irish Charities Institute and was placed with a Senior communications specialist who supported us to develop our messaging online and via radio. It was a fantastic initiative and Turas benefited from the expertise we received to develop our website, improve our Facebook content, design an ad for Dundalk FM and developed a longer term communications plan.

#### Fundraising

We also streamed lined our online donations and signed up with I donate to create an easier experience for people wishing to donate.

The Manager and a number of people took part in a walk in Ravensdale, walking 21 miles and raising €3100.

The Event Management students in DKIT organised a range of online fundraising activities including a quiz and coffee morning and raised €539 for Turas which was presented via zoom. We established our '12 tips of Christmas' campaign on Facebook to offer encouragement and positive thoughts for people with addiction as they approached Christmas.

Fundraising is a challenging arena to succeed in and we hope in 2021 to develop new initiatives to create a more sustainable future for Turas to ensure we can deliver services to people in Dundalk for the future.

We also painted our building blue to brighten our shop front and develop brand awareness locally.

All-in-all the staff and volunteers in Turas ensured that Covid did not deter us in our mission of ensuring people with addiction received the support they need and our client quotes and stories are testament to this.

Thank you to all our volunteers, staff and board members for their ongoing dedication, hard work and professionalism to Turas and to our clients who make our work worthwhile, offer feedback and keep working towards change.
