Introduction

Residential rehabilitation is defined by NICE as ‘a structured drug treatment setting where residence is a condition of receiving the interventions¹. Residential rehabilitation for the treatment of dependency on alcohol or drugs forms part of an integrated approach to treatment. NICE guidance recommends that ‘residential treatment may be considered for people who are seeking abstinence and who have significant comorbid physical, mental health or social (for example, housing) problems¹.’

One of the key parts of the Scottish Government’s National Mission on Drugs is to get people into the treatment and recovery services which are right for them. Residential rehabilitation should form part of a broad corpus of treatment options and be available to those who both wish to enter it and are deemed suitable.

In order to build capacity and expand pathways into, through and out of treatment, the Scottish Government has committed to investing £100M for residential rehab over the next five years.

A mapping exercise during February 2021, identified 20 residential rehabilitation and specialist supported accommodation services in Scotland, providing a total of 418 beds². A survey of service providers conducted in Autumn 2021, reported this has increased to 425. Decisions surrounding the provision, funding, and configuration of residential rehab, along with other local services, are undertaken locally by Integrated Authorities and Alcohol and Drug Partnerships (ADPs). In the financial year 2021/22, and for the next five years until 31st March 2026, the Alcohol and Drugs Partnerships

have been allocated £13.5M, with £5M earmarked to support additional capacity and access residential rehabilitation services³.

There are three strands to the national approach to improving access to residential rehabilitation. These include:

1. Increasing the capacity of services.
2. Improving pathways into and from residential rehabilitation services, particularly for those with complex needs.
3. Developing a standardised approach to commissioning residential rehabilitation services.

The Scottish Government wrote to ADPs on the 17 June 2021, stating that the spending of the new investment in residential rehabilitation services will be closely monitored. The Scottish Government are working alongside Public Health Scotland (PHS), to implement a data collection system to progress two separate projects which involves:

1. Tracking how the investment is translating into increased placements.
2. Monitoring outcomes of the improved access to residential rehabilitation services.

This report is intended to provide a high-level overview of the number of placements approved by ADPs between the 01 April 2021 to 30 June 2022, using statutory funding. Basic demographic information about the individuals who have been approved for residential rehabilitation is included where appropriate.

Main points

- In Q1 2022/23, 218 placements were approved for residential rehabilitation in Scotland. This is an increase of 78 placements when compared to Q1 2021/22 (n=140).
- Of the 218 placements approved in Q1 2022/23, 200 placements were approved by ADPs; 11 placements were approved by Ward 5 Woodland View in NHS Ayrshire and Arran, and seven placements were approved on the new Prison to Rehab pathway.
- The total estimated cost for the ADP approved placements and the Prison to Rehab placements in Q1 2022/23 (n=207) was £1,746,986. This cost is made up of £1,636,906 from the 200 ADP approved placements, and £110,080 for seven Prison to Rehab placements. No cost was provided for the 11 placements in Ward 4 Woodland View in NHS Ayrshire and Arran, as the service is partly funded by the three local ADPs.
- Information on the characteristics of individuals offered a placement by ADPs (n=200) in Q1 2022/23 showed:
 - 65% of placements were for males (n=130), and 35% of placements were for females (n=69).
 - 37% (n=74) of the 200 approved placements by ADPs were for people with problematic alcohol use, 37% (n=74) was for people with problematic drug use, and 26% (n=52), was for people with co-dependency.
 - The average number of monthly placements approved between 01 April 2021 and 30 June 2022 was 44. The average number of placements in Q1 2022/23 is 67.

- The largest number of approved placements by ADPs was Glasgow City (n=89, 45%), followed by Highland⁴ (n=25, 13%) and then MELDAP (Midlothian and East Lothian ADP) (n=14, 7%).
- Glasgow City ADP reported the highest estimated total cost for placements (£392,500) followed by Highland ADP (£180,478) and MELDAP (£155,539).
- There were 23 ADPs (77%), which approved placements in Q1 2022/23.
- The most common reason for ADPs submitting a nil return in Q1 2022/23 was no referrals received for residential rehabilitation.
- Between 01 April 2021 and 30 June 2022, 758 placements for residential rehabilitation were approved in Scotland. The total estimated cost was £5,198,258.
- Of the 758 placements, 663 were approved by local Alcohol and Drug Partnerships (ADPs), 64 placements were approved by Ward 5 Woodland View in NHS Ayrshire in Arran, and 31 placements were approved on the Scottish Government funded Prison to Rehab pathway.

Methodology

On the 7th September 2021, the Scottish Government advised each Alcohol and Drug Partnership (ADP) that Public Health Scotland would request data on the number of statutory funded approved placements.

Public Health Scotland (PHS) provides ADPs with a data template each quarter to capture aggregated data on ADP approved placements. Please see Appendix One for a copy of the data collection template.

A summary of placement numbers is provided by Ward 5 Woodland View in NHS Ayrshire and Arran, and also the new Prison to Rehab pathway which is funded by the Scottish Government. The data from Ward 5 Woodland View in NHS Ayrshire and Arran, and Prison to Rehab, is not included in the main body of the report since this is only based on ADP approved placements.

This data collection is an ongoing exercise to provide timely information to the Scottish Government. A full monitoring dataset is being developed which will collect data on individuals going into, through and out of residential rehabilitation. This dataset will be used to support the Monitoring and Evaluation of the Scottish Government's programme.

The following variables are on the data template:

- ADP Name
- Residential rehabilitation service provider
- Number of ADP approved funded placements approved: This was defined as the number of individual placements for which ADP funding was confirmed / approved in each month, not the number of admissions into residential rehabilitation. Data has also been captured on the number of approved placements for individuals who were referred to residential rehabilitation, but the placement was not taken up. ADPs were asked to complete the data template on behalf of other agencies such as the Local Authority or the Health and Social Care Partnership, where they are not the primary budget holder.

- Sex: Male / Female / Prefer not to say
- Substance Type: Drugs/ Alcohol / Both drug and alcohol dependency
- Estimated cost of the placement

The returned data was analysed to show the number of placements which were funded, or partially funded, by each ADP in Scotland over the reporting period, along with the substance type which the individual will be receiving treatment for. The data tables present results at national, NHS Board, and ADP level.

The estimated cost includes treatment and aftercare fees for a period after discharge from the residential rehabilitation service provider. It may also include detox costs; as a result, these figures may not be comparable with costs published elsewhere, and between other ADPs.

Due to the sensitive nature of the topic, statistical disclosure control techniques were applied to reduce the risk of identifying individuals, especially those from small geographic areas. Suppressed data have been denoted by a “*” within the data tables. Where it was not possible to show any data tables, due to the sustained and continuous risk of disclosure, a high-level text summary of the data was provided.

Findings

Number of Approved Placements

ADP Responses

Responses were received from all thirty ADPs in Scotland for the Q1 2022/23 data return. Out of the 30 responses, 23 ADPs (77%), supplied data on approved placements in Q1 2022/23.

Table One below shows the number of completed data submissions that contained information on ADP approved placements for Q1 2022/23. This is used as a gauge to measure if access into residential rehabilitation is increasing following the Scottish Government's aims of improving access, increasing capacity, and standardising the commissioning process⁵. This data must be treated with caution since we do not have a baseline comparator.

Scotland level results, 01 April 2021 to 30 June 2022

Number of Approved Placements

Table two shows the total number of statutory funded placements (ADP and non-ADP approved), split by financial year, quarter, the approving service or pathway, and the total estimated cost of the funded placements.

In total, there were 758 placements approved for residential rehabilitation from 01 April 2021 to 30 June 2022. The 758 placements had a total estimated cost of £5,198,258.

In Q1 2022/23, 218 placements were approved for residential rehabilitation with an estimated cost of £1,746,986. Of these 218 placements, 200 were approved by ADPs with an estimated cost of £1,636,906. An additional seven placements were

approved on the Scottish Government funded Prison to Rehab pathway, with an estimated cost of £110,080. Lastly, there were 11 placements for the residential rehabilitation at Ward 5 Woodland View, NHS Ayrshire and Arran. Costs have not been provided for Ward 5 placements. Data for Ward 5 and Prison to Rehab have been excluded from the main body of the report as these are not ADP approved placements. Further information on these placements can be found in the NHS Ayrshire and Arran and Prison to Rehab tables at the end of the report.

Table Three below only shows the number of ADP approved placements split by financial year, quarter, sex, and substance type, together with the estimated cost of the funded placements. The number of placements has been increasing in each quarter, excluding Q2 2021/22, with a total number of 663 ADP approved placements with an estimated cost of £4,794,213.

Table Four below shows the monthly breakdown of ADP approved placements for Q1 2022/23. The number of placements decreased from April 2022 (n=74), to 54 in June 2022. The proportion between males and females is 65% and 35%, and the proportion for substance type is 37% for both alcohol and drugs, and 26% for co-dependency.

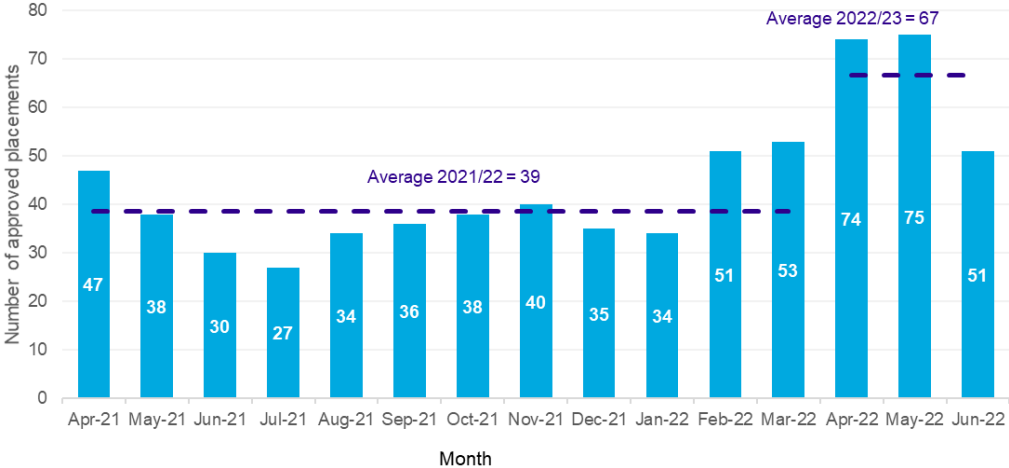

Figure one below summarises the number of monthly approved placements between 01 April 2021 and 30 June 2022. The largest number of approved placements was in May 2022 (n=75), which is the highest number recorded to date. There was a large increase in the number of placements in Q1 2022/23 (n=200), compared to Q1 2021/22 (n=115), and Q4 2021/22 (n=138). The lowest number of placements were approved in July (n=27), with low numbers seen in June 2021 (n=30), and January 2022 (n=34).

Figure 1: Number of ADP Approved Placements in Scotland, 01 April 2021 to 30 June 2022



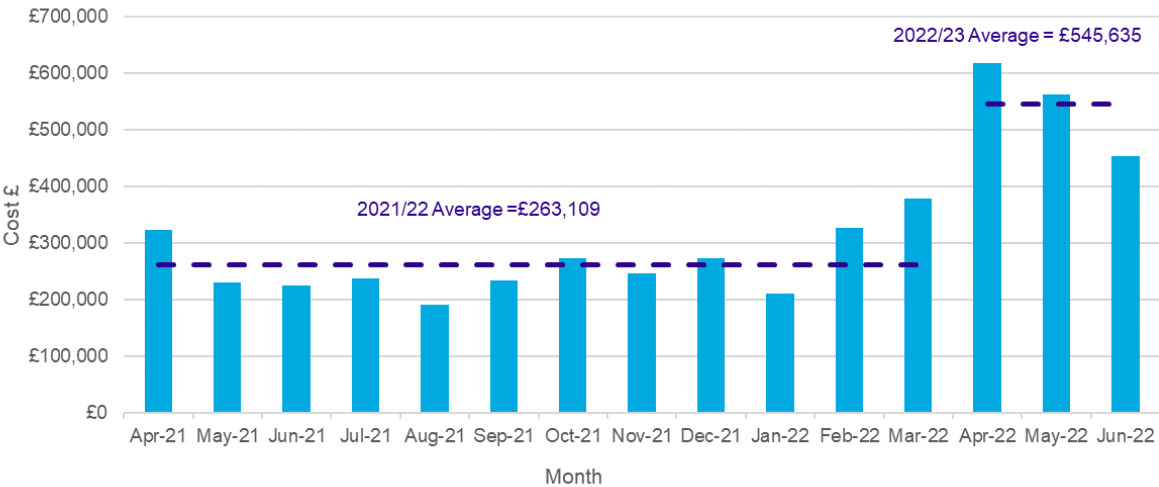
The trend in ADP approved placements decreased between April 2021 and July 2021, then increased between August 2021 and November 2021. The trend decreased during the festive period (December 2021 = 35, January 2022 = 34), but increased to over 50 placements from February 2022 through to June 2022. There was a decrease in the number of placements in June 2022 compared to the previous two months which could be due to the start of the summer holidays. The average number of placements in 2021/22 was 39, this has increased to 67 in Q1 2022/23. Overall, the average number of placements from 01 April 2021 to 30 June 2022 is 44.

Estimated Cost of ADP Approved Placements

Figure two shows the monthly estimated cost of residential rehabilitation placements in Scotland. The overall cost of 663 ADP approved placements from 01 April 2021 to 30 June 2022 is £4,794,213.

The monthly cost for placements ranged from the highest amount of £619,523 (April 2022) to the lowest amount of £191,739 (August 2021). The average monthly cost was £263,109 in 2021/22, and more than doubled to £545,635 in Q1 2022/23. This increase will be due to the larger number of approved placements in Q1 2022/23.

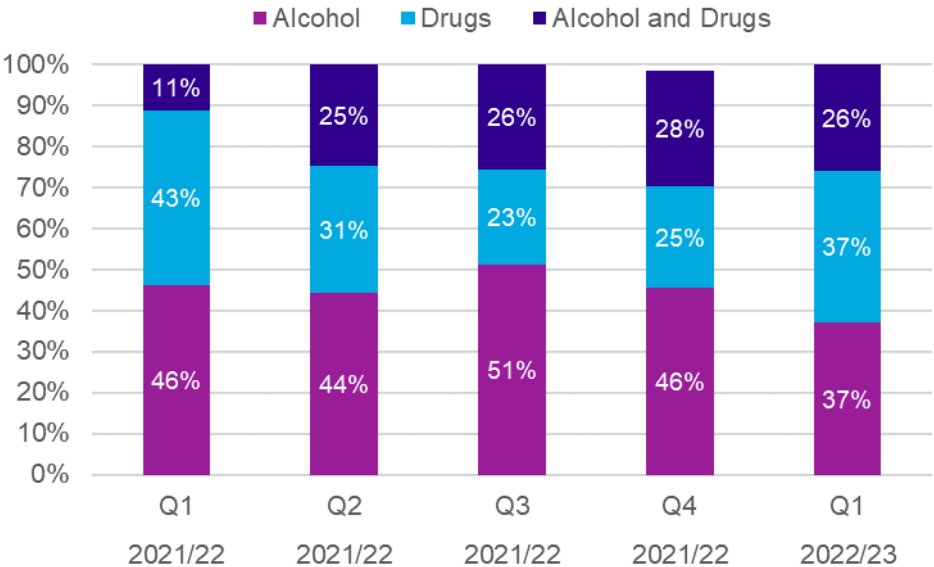
Figure 2: Estimated cost of ADP approved placements in Scotland, 01 April 2021 to 30 June 2022



Number of ADP Approved Placements by Type of Substance

Figure three below shows the proportion of ADP approved placements split by substance type for each quarter in 2021/22 and 2022/23. In 2021/22, the average proportion of placements for alcohol, drugs and co-dependency was 47%, 30% and 23% respectively. In Q1 2022/23, the proportion for alcohol placements decreased from 46% to 37%, drugs placements increased from 25% to 37%, and co-dependency placements decreased from 28% to 26%.

Proportion of ADP Approved Placements by Gender

Figure four below shows the number of ADP approved placements split between males and females from 01 April 2021 to 30 June 2022. Overall, ADPs approved placements for 438 males and 224 females, which equates to 66% and 34% respectively. This split remains relatively consistent over the time frame with the exception of December 2021 and April 2022, when the gap was at its largest. However, in June 2022, there was only a difference of two placements between males (n=26) and females (n=24).

The largest number of male placements was approved in April 2022 (n=57), and 28 placements were approved for females in May 2022. The average number of male placements in 2021/22 was 26, which has increased to 43 in 2022/23. The average number of female placements has also increased from 13 in 2021/22 to 23 in 2022/23.

Figure 4: Number of ADP approved placements by gender in Scotland, 01 April 2021 to 30 June 2022

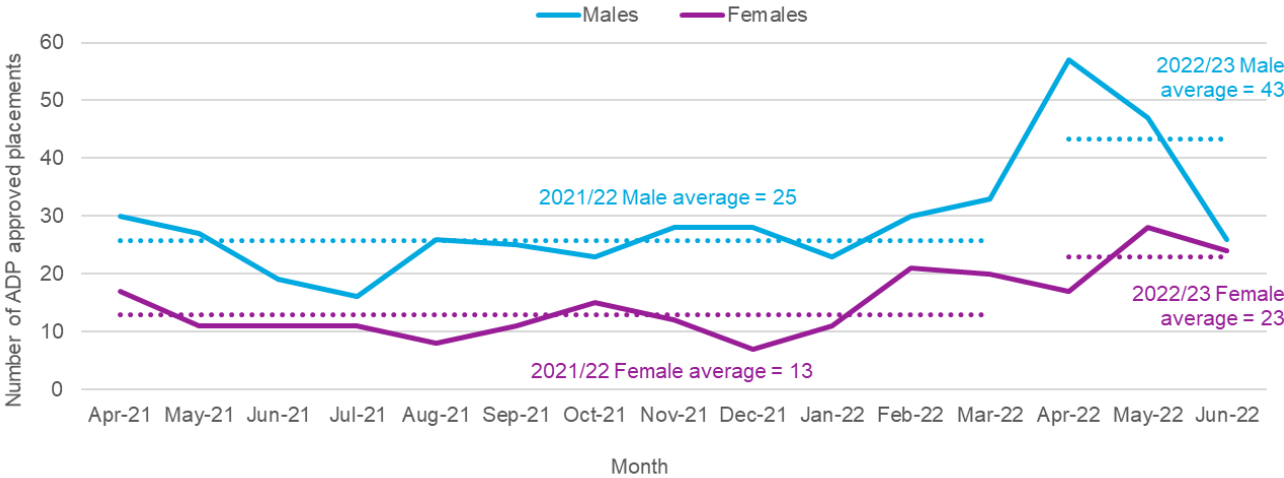
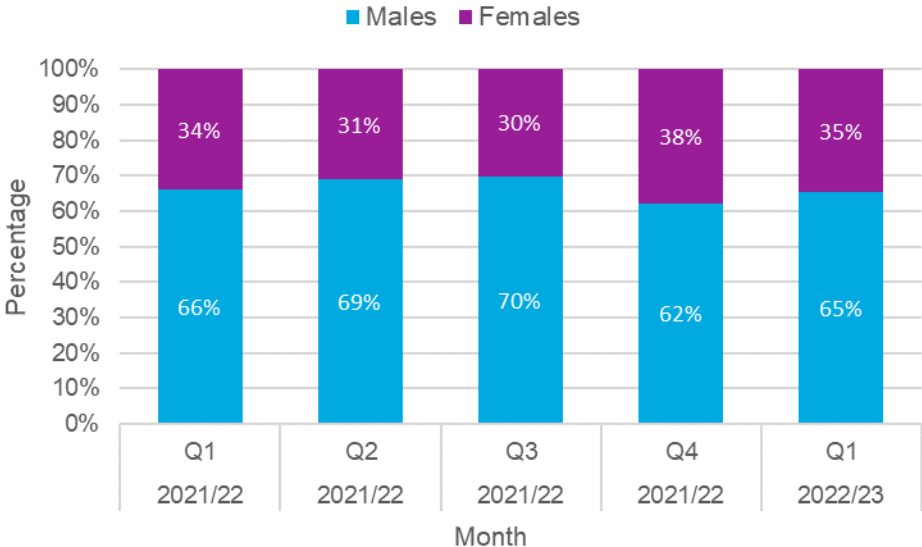


Figure five shows the proportion between male and female approved placements for each quarter in 2021/22 and 2022/23. The proportion of male placements is between 60% and 70%, whilst the proportion of female placements is lower at between 30% and 38%.

Results by ADP between 01 April 2022 and 30 June 2022

This section provides a summary of the data returned by ADPs for Q1 2022/23. Data has been presented in data tables showing the number of statutory funded placements split by month, sex, substance type and estimated cost.

Statistical Disclosure Control techniques have been applied to the data due to the sensitive nature of the topic, and to reduce the risk of identifying clients, especially those from small geographic areas. Suppressed data have been denoted by a “*” within the data tables. Where it was not possible to show any data tables, due to the sustained and continuous risk of disclosure, a high-level text summary of the data has been provided.

The estimated costs provided in this section include treatment and aftercare costs for a period after discharge from the residential rehabilitation Service Provider. It may also include detox costs which may mean that the estimated costs in this report are higher if compared to other provisional costs published elsewhere.

The data collection exercise highlighted that variation exists between the ADPs in clients accessing residential rehabilitation services. Reasons for not approving placements in residential rehabilitation since the start of the monitoring includes:

- No existing clinical pathway for residential rehabilitation clients
- Abstinence criteria not being met for accessing residential providers
- Impact of the COVID-19 restrictions
- Funding has been fully utilised for the year

Table five below lists the ADPs that did not return a completed data template. The proportion of ADPs who either submitted a nil response, or did not respond at all, has decreased from 15 in Q1 2021/22, to seven in Q1 2022/23.

The main reason for a nil return being returned was no referrals being made to the ADP for residential rehabilitation. The work on creating clinical pathways which Healthcare Improvement Scotland is leading which has led to a reduction of this reason being reported as a nil return.

The following data tables presents the total number of placements and cost in 2021/22, Q1 2022/23 and cumulative total for each ADP, the Prison to Rehab placements and Ward 5 Woodland View in NHS Ayrshire and Arran. Data has not been shown for ADPs who submitted as nil response in 2021/22 and Q1 2022/23. Please note that the data has been presented in detailed tables, or in summary text if there is a risk of disclosure.

Prison to Rehab (P2R)

The Prison to Rehab (P2R) pathway supports individuals preparing for release from prison, who may benefit from abstinence-based treatment, to access a residential rehabilitation placement. P2R was designed as a response to the COVID-19 pandemic to support individuals with histories of problematic substance use at a time when there was severe disruption to local service delivery and became operational in the summer of 2020.

A protocol and procedure document was produced in collaboration with the Scottish Recovery Consortium. It includes information on the participating providers and sets out the steps and responsibilities for prison staff and service providers. Individuals wishing to utilise P2R can choose from eight service providers ranging in location across the country and including Dundee, Inverness, and Glasgow. The Scottish Government provides funding for a 12-week placement and, if required, associated detox.
