## PQ: 35789/22:

To ask the Minister for Health if the discretionary fund of the HSE for 2022 has been exhausted; if so, if he will provide a breakdown of the way that this has happened, only six months into the year.

Dear Deputy Murphy

The Health Service Executive has been requested to reply directly to your above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

The HSE National Social Inclusion office is not aware of the discretionary fund referred to in the query. The HSE does receive funding to purchase treatment (detoxification, rehabilitation, stabilisation etc.) episodes in facilities that hold a Service Level Agreement with the HSE Addiction Services. The table below outlines the current situation in relation to treatment episodes utilised and still available in 2022
