To ask the Minister for Health the number of persons who were assessed, by facility for addiction rehabilitation and detox in 2021, in tabular form.

Dear Deputy Gould,

I refer to your above Parliamentary Question which has been referred by the Minister for Health to the Health Service Executive for direct response.

An analysis of the data provided in residential services within the National Drugs Treatment Reporting System (NDTRS) (see information about the <u>NDTRS</u>) is provided below. The analysis includes cases assessed for problem alcohol or other drugs use as a main problem in residential treatment services in Ireland in 2021. Included are all cases who were assessed for treatment in 2021, whether or not they progressed to treatment. Excluded are cases assessed in non-residential settings such as outpatient services, low threshold services, general practitioners (GP) and prison services. Once the criteria as outlined above were applied, 3,496 cases were assessed in specialised inpatient detoxification services and other inpatient treatment services.

Below table identifies residential addiction services provided directly by the HSE or Agencies that are in receipt of funding from the HSE:
