To ask the Minister for Health the status of the provision of seven new addiction midwife posts; when the posts will be filled; if the remit of these posts will be included with alcohol misuse and or substance misuse issues; and if he will make a statement on the matter. -Mark Ward

Dear Deputy Ward,

The Health Service Executive has been requested to reply directly to your above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

The table below outlines the current recruitment status of the seven new addiction midwife posts and confirmation that the remit of these posts will be included with alcohol and substance misuse issues. It must be noted that there have been ongoing recruitment challenges in the post-pandemic period and these posts are highly specialised with a limited pool of eligible applicants. The HSE Addiction Services remains committed to filling these posts as soon as possible.
