PREFACE

This publication contains a list of manufacturers authorized by Governments to manufacture narcotic drugs and psychotropic substances. The list is brought up to date and reissued on an annual basis by the Secretariat to the Governing Bodies Section (unodc-sgb@un.org), United Nations Office on Drugs and Crime.

The list was first published pursuant to provisions of article 20 of the 1931 Convention for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs; it was continued under the provisions of that Convention as amended by the 1946 Protocol; and is now issued by decision of the Commission on Narcotic Drugs on the basis of information supplied pursuant to article 18 of the Single Convention on Narcotic Drugs, 1961, and of that Convention as amended by the 1972 Protocol, and article 16 of the Convention on Psychotropic Substances, 1971.

Part I: The contents of the present list are based on data provided by States both parties and non parties to the relevant treaties on the control of narcotic drugs and psychotropic substances. It reflects data entered on the UNODC data collection portal (<https://dpx.unodc.org>) - Annual Report Questionnaire for 2021, Module 13 entitled "Legislative, institutional and strategic framework" - National Manufacturers Registry. This list is presented on a country-by-country basis in two columns. The name of each authorized manufacturer is given in English alphabetical order in the first column; if the address of the manufacturer has been made available, this information is also given in that column. The second column lists the narcotic drugs or psychotropic substances; narcotic drugs and psychotropic substances authorized for manufacture are indicated with one asterisk; narcotic drugs and psychotropic substances reported to have actually been manufactured during the year are indicated with two asterisks.

Part II: Further to a request formulated by the Economic and Social Council in resolution 1995/20 of 24 July 1995, Governments have been asked also to submit data on manufacturers of substances in Table I of the United Nations Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances, 1988. Data received from Governments are reflected in that Part.

The present publication is complete in itself, and may also be used in conjunction with the "Multilingual Dictionary of Narcotic Drugs and Psychotropic Substances under International Control" (ST/NAR/1/Rev.2, ST/NAR/1/Rev.2/Add.1, ST/NAR/1/Rev.2/Add.1/Supplement and ST/NAR/1/Rev.2/Add.1/Supplements 2 to 6), the "Multilingual Dictionary of Precursors and Chemicals frequently used in the Illicit Manufacture of Narcotic Drugs and Psychotropic Substances under International Control" (ST/NAR/1A/Rev.1 and ST/NAR/1A/Supplement) and with the "Competent National Authorities under the International Drug Control Treaties" (ST/NAR.3/2022/1), which lists the titles and addresses of competent national authorities empowered to issue certificates and authorizations for the import and export of narcotic drugs and psychotropic substances.

PRÉFACE

Le présent document contient une liste des entreprises autorisées par les gouvernements à fabriquer des stupéfiants et des substances psychotropes. Cette liste est mise à jour et publiée à nouveau chaque année par la Section du secrétariat des organes directeurs (unodc-sgb@un.org), Office des Nations Unies contre la drogue et le crime.

La liste a d'abord été publiée conformément aux dispositions de l'article 20 de la Convention de 1931 pour limiter la fabrication et réglementer la distribution des stupéfiants. La publication s'est poursuivie en vertu des dispositions de ladite Convention telle que modifiée par le Protocole de 1946 ; elle a lieu maintenant à la suite d'une décision de la Commission des stupéfiants, sur la base des renseignements fournis en vertu de l'article 18 de la Convention unique sur les stupéfiants de 1961, de cette même Convention telle que modifiée par le Protocole de 1972, et de l'article 16 de la Convention de 1971 sur les substances psychotropes.

Partie I : Le contenu de la présente liste se fonde sur les données communiquées par des États parties et non parties aux conventions sur les stupéfiants et sur les substances psychotropes. Sont prises en compte les données communiquées sur le portail de collecte de données de l'ONUDC (<https://dpx.unodc.org>), dans le module 13 du questionnaire destiné aux rapports annuels pour 2021, intitulé « Cadre législatif, institutionnel et stratégique », et dans les registres nationaux des entreprises. La liste est présentée pays par pays sur deux colonnes. La première colonne donne, par ordre alphabétique anglais, les noms de toutes les entreprises autorisées ; chaque fois que l'adresse de l'entreprise a été communiquée, ce renseignement figure également dans cette colonne. La deuxième colonne énumère les stupéfiants ou substances psychotropes : ceux dont la fabrication était autorisée sont marqués d'un astérisque ; ceux dont les rapports signalent qu'ils ont été effectivement fabriqués pendant l'année en question sont marqués de deux astérisques.

Partie II : Conformément à une demande formulée par le Conseil économique et social dans la résolution 1995/20 du 24 juillet 1995, il a été demandé aux gouvernements de fournir des données sur les fabricants de substances inscrites au Tableau I de la Convention des Nations Unies contre le trafic illicite de stupéfiants et de substances psychotropes de 1988. Les données fournies par les gouvernements figurent dans cette partie.

La présente publication est complète en elle-même ; elle peut aussi être utilisée conjointement avec le « Dictionnaire multilingue des stupéfiants et des substances psychotropes placés sous contrôle international » (ST/NAR/1/Rev.2, ST/NAR/1/Rev.2/Add.1, ST/NAR/1/Rev.2/Add.1/Supplement et ST/NAR/1/Rev.2/Add.1 Supplements 2 à 6), « Dictionnaire multilingue des précurseurs et des substances chimiques fréquemment utilisés dans la fabrication illicite de stupéfiants et de substances psychotropes placés sous contrôle international » (ST/NAR/1A/Rev.1 et ST/NAR/1A/Rev.1/Supplement) et avec la publication « Autorités nationales compétentes au titre des traités internationaux concernant le contrôle des drogues » (ST/NAR.3/2022/1), laquelle contient une liste de titres et adresses des autorités nationales habilitées à délivrer des certificats et des autorisations pour l'importation et l'exportation des stupéfiants et des substances psychotropes.

Les appellations employées dans la présente publication et la présentation des données qui y figurent n'impliquent de la part du Secrétariat de l'Organisation des Nations Unies aucune prise de position quant au statut juridique des pays, territoires, villes ou zones, ou de leurs autorités, ni quant au tracé de leurs frontières ou limites.

PREFACIO

La presente publicación contiene una lista de fabricantes autorizados por los Gobiernos para fabricar estupefacientes y sustancias sicotrópicas, lista que actualiza y reedita anualmente la Secretaría de los Órganos Rectores (unodc-sgb@un.org) de la Oficina de las Naciones Unidas contra la Drogas y el Delito.

Esta lista se publicó por primera vez en cumplimiento de lo dispuesto en el artículo 20 del Convenio Internacional para Limitar la Manufactura y Regular la Distribución de Estupefacientes, de 1931; se siguió publicando de conformidad con lo dispuesto en el texto de ese mismo instrumento modificado por el Protocolo de 1946; y se publica actualmente por decisión de la Comisión de Estupefacientes sobre la base de la información que se suministra en cumplimiento del artículo 18 de la Convención Única de 1961 sobre Estupefacientes y de esa Convención enmendada por el Protocolo de 1972, así como del artículo 16 del Convenio sobre Sustancias Sicotrópicas de 1971.

Parte I: El contenido de la presente lista está basado en los datos sobre fiscalización de estupefacientes y sustancias sicotrópicas comunicados tanto por los Estados partes como por los Estados no partes en los tratados pertinentes. La lista refleja los datos consignados en el portal de recopilación de datos de la UNODC (<https://dpx.unodc.org>) – Cuestionario para los informes anuales correspondiente a 2021, módulo 13, titulado “Marco legislativo, institucional y estratégico” – Registro de fabricantes nacionales. La lista está ordenada por países y consta de dos columnas. En la primera columna figuran, por orden alfabético inglés, los nombres de los fabricantes autorizados; cuando se ha comunicado la dirección del fabricante, esos datos figuran también en esta columna. En la segunda columna se enumeran los estupefacientes o sustancias sicotrópicas: los estupefacientes y sustancias sicotrópicas cuya fabricación está autorizada se marcan con un asterisco; los estupefacientes y sustancias sicotrópicas que, según la información comunicada, han sido efectivamente fabricados durante el año en cuestión se marcan con dos asteriscos.

Parte II: Conforme a una solicitud formulada por el Consejo Económico y Social en su resolución 1995/20, de 24 de julio de 1995, se ha pedido asimismo a los Gobiernos que presenten información sobre los fabricantes de las sustancias incluidas en el Cuadro I de la Convención de las Naciones Unidas contra el Tráfico Ilícito de Estupefacientes y Sustancias Sicotrópicas de 1988. La información recibida de los Gobiernos figura en esta parte.

Aunque la presente publicación es de por sí completa, puede utilizarse también en combinación con el *Diccionario multilingüe de estupefacientes y sustancias sicotrópicas sometidos a fiscalización internacional* (ST/NAR/1/Rev.2, ST/NAR/1/Rev.2/Add.1, ST/NAR/1/Rev.2/Add.1/Supplement y ST/NAR/1/Rev.2/Add.1/Suplementos 2 a 6), el *Diccionario multilingüe de precursores y sustancias químicas utilizados frecuentemente en la fabricación ilícita de estupefacientes y sustancias sicotrópicas sometidos a fiscalización internacional* (ST/NAR/1A/Rev.1 y ST/NAR/1A/Rev.1/Supplement) y la publicación *Autoridades nacionales competentes en virtud de los tratados de fiscalización internacional de drogas* (ST/NAR.3/2022/1), en la cual figuran los nombres y las direcciones de las autoridades nacionales competentes que están facultadas para emitir certificados y autorizaciones de importación y exportación de estupefacientes y sustancias sicotrópicas.

Las denominaciones empleadas en esta publicación y la forma en que se presentan los datos no implican, de parte de la Secretaría de las Naciones Unidas, juicio alguno sobre la condición jurídica de ningún país, territorio, ciudad o zona, o de sus autoridades, ni sobre el trazado de sus fronteras o límites.
