To ask the Minister for Health if his Department has reviewed the 2015 pilot naloxone scheme; and if he will report on same.

Dear Deputy Gould,

The Health Service Executive has been requested to reply directly to your above representation which you submitted. I have examined the matter and the following outlines the position:

The Naloxone Demonstration Project was established by the Health Service Executive (HSE) in 2015 to test the feasibility of making naloxone available for use by opioid users in order to prevent death from overdose under action 40 of the National Drugs Strategy (2009-2016) which aimed to tackle the harm caused by misuse of drugs. The Demonstration Project evaluation report contained a recommendation to continue the roll out of the project, funding was secured and HSE National Social Inclusion Office (NSIO) has been progressing the Naloxone Programme since then.

In 2022, the HSE NSIO published a report on 'Naloxone Administration by Addiction and Homeless Service Providers in Ireland: 2018-2020'. This report identified that between 2018 and 2020 naloxone was reportedly administered to 569 people. Of these, 98% survived the overdose and it was estimated that 22 lives were saved by the use of the drug.
