The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

Community Healthcare Organisation Dublin North City and County (CHO DNCC) Social Inclusion team can confirm that the table below outlines the funding received by Peter McVerry Trust from 2013 – 2023. Primary Care Addiction services commenced governance of Section 39 organisation in 2021. Therefore, Service Provider Governance (SPG) computer files are only available online from 2013 onwards. Records prior to 2013 are stored on hard copy only.

When the COVID-19 Pandemic began in March 2020 increased funding was made available to the Peter McVerry Trust. This was put in place to help facilitate the provision of Personal Protective Equipment (PPE), food and medication, for staff and individuals. Peter McVerry Trust were one of the Section 39 Organisations who assisted the HSE in the running of Isolation Units throughout Dublin during this time. These units provided accommodation and support for homeless individuals who were required to isolate during this period if they tested positive or displayed symptoms of COVID-19.
