## National Drugs Strategy

# Budget 2025 provides €4.2m & 34 whole time equivalents (WTEs) for new drugs initiatives, including

€2m + 3 WTEs to expand community-based drug services
€1m + 24 WTEs for a national rollout of community alcohol service
€0.4m + 1 WTE for harm reduction initiatives
€0.5m + 6 WTEs for drug prevention & public health awareness
€0.3m for research, evaluation and international collaboration

The full year value of the new initiatives will be €5.4m in 2026.

## **Description of new initiatives**



**Community-based drug services** to be expanded to meet increased treatment demand, with a focus on improving access to services in underserved communities, promoting evidence-based innovations in service design and delivery, and meeting the needs of people who use stimulant drugs, and those who have a dual diagnosis. €2m in 2025, rising to €2.08, in 2026.



**Integrated community alcohol treatment services** to be rolled out on a national basis. New services will be established in HSE Dublin & Midlands and in HSE Dublin & South East, and existing services expanded to ensure full geographic coverage across all health regions.  $\leq 1m$  in 2025;  $\leq 1.8m$  in 2026.



**Harm reduction** initiatives to provide a rapid response to the threat of synthetic drugs, a wastewater drug surveillance programme, a national awareness campaign and capacity building on drug-related violence and intimidation, and extended opening hours for the supervised injecting facility. €0.4m in 2025; €0.43m in 2026



**Drug prevention programmes and public health awareness campaigns** to be developed across the health regions and screening and brief interventions to be scaled up. €0.5m in 2025; €0.79m in 2026



Initiatives to **support research, evaluation and international collaboration**. €0.3m in 2025 & 2026

### **Expected Outcomes**

- increase in the number of people who attend for treatment for drug and alcohol dependency
- telehealth service for people seeking alcohol treatment services, linking community services, primary care, GPs, community care and hospitals
- evidence-based drug prevention interventions
- public awareness of health risks of drug and alcohol use
- more supports for individuals, families and communities affected by drug-related violence and intimidation
- equitable access to drug and alcohol services across all health regions
- public health drug monitoring
- timely response to emerging health threats from synthetic drugs.

### The new initiatives will support the implementation the national drugs strategy by


- enhancing access to and delivery of drug and alcohol services in the community,
- developing harm reduction responses and integrated care pathways for high-risk drug and alcohol users,
- strengthening the prevention of drug and alcohol use among children and young people and
- minimising the harms of drug and alcohol use in disadvantaged communities.



The new initiatives are aligned with the recommendations from the Citizens Assembly on Drug Use, in particular #s 15, 18, 26, 27, 29, 31, 32, 33 & 36
