Familial Regulation

This section presents results from analyses that examine associations between teenagers' cigarette use (lifetime and current) and a range of familial regulation measures and attitudes, such as how much parents set rules about what students can do, both at home and outside home, parental monitoring of students' whereabouts in the evenings, and with whom they spend their time, and students' perceptions of their parents' attitudes to cigarette use. Associations between another measure of familial monitoring (of teenagers' whereabouts on Saturday nights) and teenager cigarette use are described in the main ESPAD report.
