## **About Safe Futures**

Safe Futures brings together policymakers, researchers, law enforcement agencies, and practitioners from across Europe to collaborate in a new Community of Practice focused on interventions to prevent Youth Recruitment and Participation in European Drug Markets.

Led by REPPP in the University of Limerick on behalf of the European Union Drugs Agency (EUDA), this project is building on existing initiatives to inform and design future responses to the problem of young people's involvement in drug markets and drug-related criminal activities.


The overall purpose of the project is to establish a multi-disciplinary and jurisdictional network (policymakers, academics, practitioners, law enforcement) from 3-5 EU countries to support:

- A Desk Review of literature on interventions, evaluations etc
- Identification and review of existing examples of practices and interventions
- Identification of critical lessons learned, success factors and barriers to the development and implementation of interventions
- Development of a conceptual framework and model to inform the development and implementation of interventions
- Communication of the project findings to researchers and practitioners in this area.

## Building a Community of Practice

An important objective of Safe Futures is to establish a multi-disciplinary and multi-jurisdictional community of practice focused on developing new approaches and interventions to target the recruitment and participation of young people in European Drugs Markets.

To support and lead this work, a Core Group representing partners from Ireland, Northern Ireland, Sweden, The Netherlands, and the EUDA has now been formed.

### Safe Futures Launch

The Safe Futures project was officially launched at a meeting of the Project Core Group Partners and guests in the offices of the EUDA in Lisbon on the 19<sup>th</sup> and 20<sup>th</sup> July.



The 2- day meeting brought together policymakers, academics, and law enforcement agencies from the Core Group member countries to discuss the challenges and opportunities for developing interventions for the prevention of recruitment of young people in European Drugs markets. The meeting provided a space for networking, relationship-building and exchange of knowledge and ideas.



## Safe Futures Launch

Day 1 commenced with a reflective discussion on the concept of a community of practice, highlighting the importance of sharing knowledge and expertise, as well as the different objectives, methods, restraints and priorities for sharing knowledge.



Over the remainder of the 2 days, attendees presented and discussed some of the research they have undertaken as well as the practice challenges they are grappling with. Attendees discussed learning from Ireland's Greentown Programme; the Netherland's Prevention with Authority Programme; the use of 'credible messengers' in The Netherlands; a relational youth work and hospital-based violence intervention programme in Northern Ireland; focused deterrence models and support; and the importance of sharing local and national experiences and insights across multiple jurisdictions.

## Project Activities

#### Reviewing Literature

We are currently undertaking a Rapid Evidence Review of both academic and grey literature, focusing on new and innovative approaches to tackling the complex problem of young



people's involvement in drugs markets and criminal networks.



#### **Engaging with Stakeholders**

Over the next 12 months, we will be reaching out to policy makers, practitioners, law enforcement agencies, and academics to learn about the innovative research and practice happening across Europe.

#### **Communicating our Learning**

We will continue to communicate and share learning from the project, with our first webinar scheduled for the Autumn.


## **Upcoming Events**

#### Call for Abstracts

# Do you want to do something about serious youth violence and youth involvement in organised crime?

Then think about submitting to a special issue of 'Behavioural Sciences' with guest editors Dr Seán Redmond, REPPP, and Dr. Colm Walsh, Queens University Belfast.

Systematic reviews of the extant evidence about youth involved in serious violence and organised crime are yielding little in terms of interventions that are sufficiently impactful.

There is a knowledge gap between what science can tell us about what works and how the problem of serious youth crime presents in all its complex reality. This special issue is aiming to help close this gap, and is looking for evidence based and evidence informed contributions that throw new light on potential solutions.

The work of the Project is being led and co-ordinated by Helen Fitzgerald and Dr Eoin O'Meara Daly.


