- Indirect dissemination recognising that the Unit may not always be best placed to communicate directly with some sections of its audience.
- **6.** This initial policy statement will be evaluated at six-monthly intervals to ensure that the Unit is reaching its key audiences and that its output continues to be relevant and to add value to the work of those in the field.

#### **INTRODUCTION**

In this fourth Effective Interventions Unit programme, we will continue to identify, disseminate and support the implementation of the effective practice as identified in our reviews, research reports and guides. In 2004-05, we will be giving more attention to support for implementation.

Over the last year, we have been testing out in a limited way how we might offer facilitation and support to DAATs, partner agencies and service providers to help them apply the evidence in our documents in their own local circumstances. The external evaluation of the Unit's impact carried out by Clear Plan UK and the Unit's informal review showed that there is a demand for the EIU to offer a greater level of support. The forthcoming Treatment and Rehabilitation Review is likely to suggest an enhanced role for EIU in facilitating and supporting effective practice. The Unit, will, therefore, devote more time and staff resources to developing the facilitation and support role, in partnership with DAATs and agencies at local level, in 2004-05.

The external evaluation and the informal review also sought views on the possible extension of the EIU remit to alcohol. There was a strong consensus that there is a need for a similar function in the alcohol field to identify what is effective practice and that it would be sensible and cost-effective for the EIU to extend its current approach and methodology to cover alcohol.

In order to develop the Unit's role in these ways, it seems likely that the Unit will need flexibility in recruiting staff, developing new skills and adopting new ways of working. For this reason, in the coming year, the Unit will be working with colleagues in the Executive and other agencies to consider options for its structure and location. We will publish information on progress through our web pages.

#### **The Unit Team**

The Unit Team continues to be a mix of civil servants, researchers and secondees. This brings to the Unit a mix of knowledge and skills.

In 2003-04, two members of the Unit team moved on: Sandra Muir and Nick Bland.

Sandra Muir left the Unit in April 2003. She provided general administrative support with a combination of enthusiasm and efficiency. She also provided a helpful point of contact for callers to the Unit.

Nick played a key role in getting the research Programme up and running, including the research on the policing of low-level drug markets and the evaluation of the Lloyds TSB Partnership Drugs Initiative Projects. He was also instrumental in the development of the Unit's model of evidence gathering.

#### THE UNIT'S APPROACH

The Unit has built on its original model to adopt a range of approaches to evidence gathering. That model incorporated:

- > Reviewing research and evaluation evidence
- A mapping of current provision (if appropriate)
- Qualitative studies to elicit views and experiences of service providers and service users
- ➤ Identification of key principles and elements of effective practice
- > Active dissemination using a mix of internet publication, published material and seminars around Scotland.

In the past 3 years, this model was the basis of our reviews and guides on employability (Moving On), young people with problem drug use, integrated care and family support. In addition, we consult with a range of people from agencies and services who deal with people with drug misuse problems and draw on the knowledge and experience of our Reference Groups and working groups.

While we continue to use the elements of that model, we are now developing our research and evidence gathering through a variety of other methods: for example, telephone surveys, seminars with key professionals, interviews and visits to services.

#### **Facilitation and support**

In the last year, we have had the opportunity to run joint, local seminars with West Dunbartonshire Council on young people and Midlothian DAAT on integrated care. These seminars were designed to explore how the EIU evidence base could be applied to their local circumstances and have provided useful lessons to build on for future events.

The Unit now plans to put more effort into collaborating with DAATs and local partners to organise local seminars or workshops tailored to local needs and circumstances. We have already begun this process for **information sharing** which is core to the development of integrated care. We developed our proposals for the information sharing workshops with a working group drawn from DAATs and other key players and we are now following the same process for **integrated care**. Plans for **employability** workshops are in the early stages.


We are also keen to explore the possibilities of facilitation with local teams or groups who have a specific remit e.g. to develop an employability action plan, carry out a needs assessment or a system of care co-ordination. In this context, EIU could provide a neutral and objective person to reflect on the current evidence of effective practice and facilitate discussions about the way ahead on key topics and issues.

#### **Support for evaluation**

To date, we have made less progress on support for the evaluation of pilots or innovative services to test out new approaches to service design and delivery. We are engaged with the evaluation of the Community Addiction Teams in Glasgow and with the pilot psychostimulant service in Aberdeen. In the coming year we will explore further opportunities in support of the action arising from the Treatment and Rehabilitation Review. More recently, we have supported 2 DAATs in the design of evaluations of services. We would be interested in doing more of this kind of activity.

#### **Methods of Working**

We continue to work in an open way and to engage with a wide range of people from a range of agencies and service providers developing and disseminating our work. In 2003-04 we held 8 events attended by 375 people. We have again used Reference Groups and smaller working groups drawn from Drug Action Teams, health and social care professionals, drug services, employability services, researchers, managers and practitioners. This year we have used a new technique of telephone interviews carried out by team members to inform our work on information sharing and needs assessment. We commissioned SDF to carry out a focus group study to gather views of service users about advocacy. We also carried out a series of visits to services. We have published 16 guides, reviews and research reports. Details are set out in Appendices A to C.

#### A. IDENTIFYING AND PROMOTING EFFECTIVE PRACTICE

#### A1. OUTCOMES AND EVALUATION

Since the EIU's establishment, we have devoted considerable time and resources to promoting the understanding and use of evaluation among service commissioners, planners and providers. We have done this through the series of evaluation guides and then through the funding of workshops run by the consultants, Partners in Evaluation, in all DAAT areas. While the feedback on both guides and the workshops has been positive, our external evaluation has shown that our work has made little or no impact on practice in the field. In 2004-05, we will continue our involvement with the proposal for a national evaluation service and consider other ways to support evaluation practice.

#### Progress in April 2003-March 2004

- We produced two thematic evaluation guides to support the evaluation of specific services. These were 'Intensive Interventions with Young People', developed in collaboration with the Lloyds TSB Partnership Drugs Initiative (PDI) Programme Manager (November 2003), and 'Supporting the Families and Carers of Drug Users' (April 2004).
- In partnership with the Executive's Voluntary Issues Unit, Lloyds TSB Partnership Drugs Initiative, the Communities Fund and other charitable organisations, we cofunded and supported a study to determine the feasibility of establishing a national evaluation service for the voluntary sector. We are now part of the Implementation Group.

#### Plans for April 2004-March 2005

- We will collaborate with Scottish Drugs Forum to produce an Evaluation Guide tailored to the needs of Family Support Groups. We will continue to develop thematic evaluation guides as appropriate.
- We will continue to work with partners to support the ongoing work to develop a national evaluation service.
- We will offer support for the design of service evaluations.

#### A2. RESEARCH

• In the past year, we have continued to commission major projects from the Drugs Misuse Research Programme. These are described in detail below. The first three years of the Drugs Misuse Research Programme are now at an end. We have been consulting with interested parties in the Executive and across a wide range of agencies to develop the content of the Programme for 2004-07. The new Programme will be published in **June 2004.** 

#### Progress in April 2003-March 2004

• We continued our programme of research on the prevention of transmission of Hepatitis C. We commissioned an evaluation of a Hepatitis C peer education project called C-Level (May 2003). We also commissioned an evaluation of the impact of changes in the Lord Advocate's Guidance on the number of needles and syringes that can be issued at one time (October 2003). We published 'Examining the Injecting Practices of Injecting Drug Users in Scotland' (February 2004). Following the completion of the Injecting Practices study, we commissioned the second phase of this work: a laboratory based study of safety, risks and outcomes from the use of different forms of injecting paraphernalia among injecting drug users. We held an event to disseminate the results of the Injecting Practices study in **March 2004**.

- We also published the final report of one of the studies funded under the research competition run in Autumn 2001: 'Measuring staff attitudes to people with drug problems' (August 2003).
- We continued to manage the major evaluations of the Scottish Prison Service's Transitional Care programme and selected young people's projects funded by the Lloyds TSB Foundation Partnership Drugs Initiative.
- We commissioned research on the provision of services for people with co-existing mental health and substance misuse problems in **November 2003.**
- We undertook a review of the literature on the effectiveness of residential rehabilitation and detoxification services for drug users. The findings were used to inform the review of treatment and rehabilitation services being undertaken by the Scottish Executive Substance Misuse Division.
- We commenced further work on local drug markets in three case study areas in Scotland, which is currently ongoing. So far, this has involved interviewing police officers and drug service providers.
- We commissioned in **December 2003**, a National Investigation into Drug-related Deaths which will aim to make recommendations for policy and practice to reduce the incidence of drug-related deaths in future.
- We carried out interviews with drug workers and specialist counselling staff in a small number of agencies across Scotland to inform our future research on psycho-social interventions for drug misuse.
- We continue to support the Robertson Trust Research Programme being conducted by the Centre for Drugs Misuse Research at Glasgow University through a Scottish Executive Advisory Group. The main project under this programme, Drug Outcomes Research in Scotland (DORIS), is a longitudinal study following up a large cohort of drug users over a period of years. The second round of follow-up interviews with this cohort has recently been completed.
- We continue to contribute to the three year funding given by the Scottish Executive
  to help support the Edinburgh Study of Youth Transitions and Crime conducted by
  Edinburgh University. This will continue to provide specific reports on findings related
  to the development of substance misuse among this cohort of young people.
  Forthcoming reports include a report on the 'relationship and interdependence
  between the use of alcohol, tobacco and other drugs'.
- We continue to maintain links with other UK research funders to ensure that the
  research programme is informed by and contributes to the developing UK-wide drugs
  research evidence base. We contribute to the UK Research and Information Working
  Group (RIWG) which brings together researchers from UK and Irish government
  departments and devolved administrations. We also contribute to advisory groups
  for specific research studies funded by the Information and Statistics Division, NHS
  Scotland.

#### Plans for April 2004-March 2005

- We will publish the interim research report of the evaluation of Lloyds TSB PDI projects in April 2004. The report 'Working with Young People' gives profiles of 17 projects. The next phase of the evaluation will be a longer-term evaluation of a small number of case study projects. The evaluation will include both process and outcome elements.
- We will publish 'Reducing the impact of local drug markets: A research review' in April 2004. We will commission further work on drug markets including the interviewing of drug users and members of the wider community in case study areas.
- Other reports due to be published in 2004-05 are:

Interim findings from the Prison Transitional Care evaluation (**April, June** and **November 2004**)

A review of residential detoxification and rehabilitation services for drug users in Scotland (**June 2004**)

An exploration of the role of substance misuse nurses in Scotland (**July 2004**)

Evaluation of C-Level peer education intervention (October 2004)

Evaluation of new intervention for Neo-natal Abstinence Syndrome and visual impairment in infants of substance misusing mothers (**November 2004**)

National Investigation into drug-related deaths (December 2004)

Evaluation of the impact of the change in the Lord Advocate's Guidance on needle and syringe exchange (**February 2005**)

Research into service provision for people with co-morbid mental health and substance use problems in Scotland (March 2005)

- Many of the long-term research studies we have commissioned, such as the evaluations of Prison Transitional Care programme and the Lloyds TSB Foundation Partnership Drugs Initiative, and research competition projects, will continue throughout 2004-05.
- We will hold a second dissemination seminar on the research relating to Hepatitis C prevention in **June 2004**.
- We will continue to support the monitoring and evaluation of the pilot psychostimulant service set up in Aberdeen (the 'Incite' project). The pilot service is now operating and an external evaluation will be commissioned in **June 2004**.
- We will continue to provide support to the process evaluation of new Community Addiction Teams in Glasgow which integrate health and social work addiction services. The evaluation is due to finish in February 2005.
- The study of the safety, risks and outcomes from the use of injecting paraphernalia, funded through the research competition in August 2001, will report in **February** 2006.

- We will commission or co-fund further research on
  - counselling and other psycho-social interventions
  - the effectiveness and cost-effectiveness of residential rehabilitation
  - effectiveness of buprenorphine.
- We will scope requirements for future research into
  - drug markets
  - families affected by problem drug use (in particular, drug misusing parents and their children)
- The Robertson Trust Research Programme will be ongoing over 2004-06. The Scottish Executive has agreed to contribute to the future funding of this work.
- This ongoing and planned research is also discussed in the following sections under the appropriate thematic headings and a full summary of all this work is at Appendices D -F.

#### A3. DISSEMINATION

#### Progress in April 2004 to March 2005

- We have continued to disseminate our publications to a wide audience DAATs, NHS
  Boards and Trusts, Local Authorities, including Social Work and Education
  Departments, drug services in the statutory and voluntary sectors, agencies in the
  education, training and employment sectors, Prisons, Police, Social Inclusion
  Partnerships, research bodies and UK bodies.
- The external evaluation of the impact of the EIU (January 2004), showed that the Unit's work is well-regarded for its quality and accessibility. Our outputs are used in a variety of ways including as learning tools, catalysts for reviews of practice, as the basis for multi-agency reviews and as design templates. The evaluation offers a number of ideas for increasing the impact of EIU outputs and, in particular, it supports the idea of facilitation and support
- In collaboration with ISD, we have continued to develop the web pages. In **August 2003**, we added a page about our seminars including copies of presentations where available and the feedback. New research web pages were added to the site in **January 2004**. Between October and November 2003, we put on a pop-up questionnaire concerning the possible use of CD Roms for our publications. The outcome was that there was not enough interest at the moment. The web pages had an average of 9500 hits per month last year.
- We held 8 seminars and consultation workshops, including 2 local, joint workshops, in the course of last year
- Members of the EIU team have reviewed the Unit's dissemination policy with a view to heightening awareness of our work in areas where there has been a lower level of engagement. We also explored ways of developing the use of the display stand and the publications material. The display material has been updated and revamped.

#### Plans for April 2004-March 2005

- We will continue to seek opportunities to take the EIU stand and publications to local events to ensure that our material is available to as wide an audience as possible. - We will continue to develop the web pages and we would welcome comments and suggestions.
- We will continue to hold seminars and workshops during 2004-05. Topics are likely to include injecting practices, needs assessment, Integrated Care Pathways Guides and advocacy. In addition we will be seeking opportunities to collaborate on locally based workshops.

#### B. YOUNG PEOPLE

#### **B1. PREVENTION AND EDUCATION**

#### **Progress in April 2004-March 2005**

- The Scottish Executive Education Department has commissioned an evaluation of the effectiveness of drug education in Scottish schools. The purpose of the research is to examine how drug education is currently delivered, how practice reflects what is shown to be effective in the literature, and to consider the views of young people on its value and impact on them. The report is due by **December 2004**.
- On behalf of the Substance Misuse Division, we commissioned and managed an
  evaluation of a pilot intervention among retailers in Fife to prevent Volatile Substance
  Abuse (VSA). The aim of the intervention which involved the distribution of
  leaflets, a poster and other materials was to raise awareness among retailers of
  the legislation which prohibits the sale of solvent products to young people under 18.
  The encouraging results from the Fife evaluation will lead to the intervention being
  rolled out to retailers across Scotland.

#### Plans for April 2004- March 2005

• We will explore the potential for developing work on effective approaches to VSA prevention in the light of recent concerns about its increasing prevalence.

#### **B2. TREATMENT AND CARE SERVICES FOR UNDER 16s**

#### **Progress in April 2004-March 2005**

- In partnership with Nicola Richards, the then Programme Manager for the Lloyds TSB Foundation Partnership Drugs Initiative (PDI), we produced an Evaluation Guide for Intensive Interventions with Young People (**November 2003**).
- We have consulted extensively through a series of visits and consultation workshops on the development of effective assessment for young people. This exercise has also involved liaison with other parts of the Executive who are taking forward work on assessment of children and young people including ecare pilot projects and child protection policies. We have also benefited from the advice and support of the Young People's Assessment Reference Group. From this evidence gathering, we have identified a number of other issues and ideas for future work.
- The evaluation of projects working with vulnerable young people funded by the Lloyds TSB PDI continued.

#### Plans for April 2004-March 2005

- We will publish the interim research report of the evaluation of Lloyds TSB PDI projects in April 2004. The report 'Working with Young People' gives profiles of 17 projects. The next phase of the evaluation will be a longer-term evaluation of a small number of case study projects. The evaluation will include both process and outcome elements.
- We will consider the possibility of co-funding research on family therapy.
- We will publish a guide to assessment for young people with, or at risk of developing, problematic substance misuse by August 2004.

• In the course of our extensive consultations in support of our work on assessment, we have become aware of the number of children and young people who are caring for a drug using parent or relative. In collaboration with other Scottish Executive Divisions, we will undertake a mapping of what services currently exist for children and young people caring for drug using parents. This is likely to cover the extent of the problem, location, referral criteria and the level and pattern of use of such services.

#### Progress in April 2003-2004

• We produced an Evaluation Guide on Supporting the Families and Carers of Drug Users to be published in **April 2004**.

#### Plans for April 2004-March 2005

• We will collaborate with Scottish Drugs Forum to produce a guide on evaluation designed to help family support groups understand the importance of evaluation and how they might apply basic evaluation techniques to their activities.

#### C2. ARREST REFERRAL

#### Progress in April 2002-March 2003

• Following the allocation of funding by the Justice Department to a number of arrest referral schemes, EIU contributed to the development of a national Arrest Referral monitoring framework co-ordinated by ISD.

#### Plans for April 2004 March 2005

 We will continue to take opportunities to support the development of the evidence base for effective Arrest Referral schemes.

#### C3. TRAINING AND EMPLOYMENT

 Programmes to improve training and employment for drug users have a potential impact on the wider community. Details of our work on this topic are set out under Section D Treatment and Rehabilitation.

#### C4. POLICING LOCAL-LOW LEVEL DRUG DEALING

Local low-level drug dealing has a significant impact on the communities in which it
takes place. The research to evaluate police action against drug dealing (see
description under **Section E Availability** for more detail) will include a focus on how
drug dealing affects the communities in which it takes place, and whether and how
police work reduces this impact on communities.

#### D. TREATMENT AND REHABILITATION

#### **D1. INTEGRATED CARE**

#### Progress in April 2003-March 2004

- We have continued to produce Integrated Care Pathway Guides with the support of a Working Groups drawn from health, social work, and the voluntary sector. In July 2003 we published 'Developing Integrated Care Pathways' (Guide 2); in January 2004, 'Implementing Integrated Care Pathways' (Guide 3). Guide 4, 'Analysis and Review' will be published in April 2004.
- In **January 2004**, we published 'A Practical Guide to Needs Assessment for Drug Users' which sets out the rationale for the strategic process of needs assessment, identifies the key components and provides a step-by-step guide. The guide was developed following a telephone survey of DAATs and a review of the literature on needs assessment. A working group drawn from key agencies supported this work.
- We have taken forward evidence gathering to support the development of a Guide to Advocacy for Drug Users. In the course of 2003-04, we reviewed research and policy documents on the principles and practice of advocacy, carried out a survey of advocacy services, held a consultation seminar and commissioned Scottish Drugs Forum to conduct a focus group study with service users.
- We took forward our commitment to support the development of **information sharing**. We set up a short-life working group and carried out a DAAT telephone survey to find out more about local information sharing developments and support needs. The EIU has now commissioned an external consultant to provide facilitation support, in the form of workshops, to all DAATs who wish them. Workshops will be tailored to meet local needs, recognising that areas are at different stages of development. The first 3 workshops were held in **March 2004** in Dumfries and Galloway, Fife and Highland. The EIU is also working with DAATs to encourage publication of local information sharing materials on the DAAT pages of the Drug Misuse Information Scotland website, to assist the exchange of practice examples between areas.
- In conjunction with Greater Glasgow NHS Board, Greater Glasgow Primary Care NHS Trust and Glasgow City Council, we continued to support the evaluation of the working of two new integrated Community Addiction Teams.
- We agreed with the Joint Future Unit and the DAT Association to promote and support the development of integrated care, both at strategic and operational level, by offering joint, local workshops tailored to local needs and circumstances. We have organised one workshop in Midlothian (February 2004) which has provided useful lessons for the future. We have set up a working group from NHS, social work and the voluntary sector to help us devise the framework, content and format for the workshops.
- We engaged in preliminary discussions with DAATs about the issues that impact on the development of integrated care in rural and remote areas.

#### Plans for April 2004-March 2005

- We will continue to promote and support the implementation of integrated care.
- We will publish 4 Integrated Care Pathway Guides: Community Detoxification (**June 2004**); Care of People with Drug problems in Psychiatric Settings (**August**

**2004**); Drug Misuse in Pregnancy (**October 2004**); and Care of People with Drug Problems in Acute Medical and Surgical Settings (**December 2004**). We will collaborate with the Joint Future Unit on an ICP Guide to Single Shared Assessment (**October 2004**). In the autumn, we will hold 3 seminars on Integrated Care Pathways.

- We will publish a Guide to Advocacy for Drug Users in June 2004.
- We will offer local workshops to DAATs and partner agencies on integrated care, in partnership with the Joint Future Unit and the DAT Association.
- We will evaluate the first 3 information sharing workshops to inform the design of the subsequent workshops to be held throughout the year.
- We also plan to hold regional seminars on needs assessment, Integrated Care Pathways and advocacy. However, in line with our focus on facilitation and support we would also be willing to collaborate with DAATS and other local agencies on running local events.
- We will examine the issues in developing integrated care in rural and remote areas and produce a document on effective approaches to the commissioning, managing and delivery of drug services in rural and remote areas by **December 2004**.

#### **D2. EFFECTIVENESS OF TREATMENT**

#### Progress in April 2003-March 2004

- We undertook a review of the literature on the effectiveness of residential rehabilitation and detoxification services for drug users, and the findings were used to inform the review of treatment and rehabilitation services undertaken by the Scottish Executive Substance Misuse Division.
- At the request of the Deputy Justice Minister, we commissioned a National Investigation into Drug-related Deaths (**December 2003**). This Investigation will undertake a detailed examination of the social and clinical circumstances surrounding all drug-related deaths in Scotland in 2003.

#### Plans for April 2004-March 2005

- We will publish a review of residential detoxification and rehabilitation services for drug users in Scotland (**June 2004**).
- In the course of the year we will commission or co-fund further research on
  - counselling and other psycho-social interventions
  - effectiveness of residential rehabilitation
  - the effectiveness of buprenorphine
- We will publish the findings from the National Investigation into Drug-related Deaths (December 2004), and a report comparing the circumstances of Scottish drug-related deaths with drug-related deaths in London in the same period (March 2005).

#### D3. HEPATITIS C

#### Progress in April 2003 - March 2004

- We commissioned an evaluation of a Hepatitis C peer education project called C-Level (May 2003). The aim of the evaluation is to explore the views of staff, clients and funders of the C-Level project, to describe the nature and range of services offered by the project, and to examine the experience of recruiting, training, and supporting the peer educators.
- We commissioned (October 2003) an evaluation of the impact of changes in the Lord Advocate's Guidance on the number of needles and syringes that can be issued at one time.
- We published the report of the research on Examining the Injecting Practices of Injecting Drug Users (**February 2004**) and held a dissemination seminar in **March 2004**.
- We commissioned the second phase of the injecting practices research in **November 2003**. This is a laboratory based study of safety, risks and outcomes from the use of different forms of injecting paraphernalia among injecting drug users. This study is due to be completed in (**February 2006**).

#### Plans for April 2004 - March 2005

- We will publish
  - report of the C-Level evaluation October 2004
  - report of evaluation of Lord Advocate's Guidance in February 2005.

#### D4. SPS TRANSITIONAL CARE

#### Progress in April 2003 - March 2004

• We continued to manage the evaluation of the Scottish Prison Service's Transitional Care programme.

#### Plans for April 2004 - March 2005

• We will publish interim findings from the SPS Transitional Care evaluation (**April**, **June** and **November 2004**).

#### **D5. TRAINING AND EMPLOYMENT**

#### Progress in April 2003- March 2004

• We published the Moving On Update in **October 2003**. The Update reflects more recent developments in employability provision and examines the importance of the role of employers and the requirements of local labour markets. We developed the Update with the support of a working group.

#### Plans for April 2003-March 2004

 We plan to develop and offer locally based workshops on the development of employability provision for drug users. The workshops will also reflect recent developments in the Healthy Working Lives strategy being developed by Substance Misuse Division as part of the implementation of the Health Improvement Challenge.

#### D6. PSYCHOSTIMULANTS

#### Progress in April 2003- March 2004

 We have continued to support the development of the pilot service for psychostimulant drug users in Aberdeen. Development of the pilot service (the 'Incite' project) has been informed by needs assessment work conducted by the pilot project staff, in partnership with EIU, and the service began operating in **March** 2004.

#### Plans for April 2004 - March 2005

• We will support the on-going monitoring and evaluation of the pilot psychostimulant service in Aberdeen (the 'Incite' project). An external evaluation of the service will be commissioned in **June 2004**.

#### **D7.** CO-MORBIDITY

#### Progress in April 2003- March 2004

- We conducted an in-house review of existing literature. We also supported the work of the SACAM/SACDM Multi-Mental Health Working Group.
- We commissioned a study on the provision of health & social care services for people with co-existing mental health and substance use problems in Scotland in **November** 2003.

#### Plans for April 2004 - March 2005

• The study on existing service provision in Scotland for people in this client group is due to be published in **March 2005.** This may lead to further research.

#### **E AVAILABILITY**

#### Progress in April 2003 - March 2004

- We undertook a review of existing research evidence on the policing of local low-level dealing. This also drew on early findings from EIU visits to Scottish police forces.
- We also commenced work on a more detailed study of drug markets in three 'case study' areas. So far this has included interviews with a range of police officers and local drug service providers in the case study areas. This study will also be informed by interviews with drug users and members of the wider community, in the case study areas.

#### Plans for April 2004 - March 2005

- A review of existing research evidence on the policing of local low-level dealing, 'Reducing the impact of local drug markets', drawing also on early findings from our force visits, will be published in **April 2004**.
- We will continue with our case study research, which will include the completion of
  in-house work with the police and local service providers. It will also include the
  commissioning of qualitative work with drug users and the wider community, in May
  2004. We hope to publish a report drawing all of these strands of the case study
  research by summer 2005.
